I, SI Ganesh Roy of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Satya Das, aged 37 years S/o Nitya Nanda Das of Baribhasa, Bansh Bari PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;

1. 12 (Twelve) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that on 02.08.24 at 22-25 hrs received source information that one person was selling Liquor illegally from his house at Kashmir Colony near Railway Guest House under New Jalpaiguri PS, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith SI Tanmay Kundu, C152 Abdul Kayum Mia, VP 13 Jamrul Islam all of NJP PS, SPC left for Kashmir Colony near Railway Guest House to verify the veracity of information vide NJP PS GDE No. 140 Dated- 02.08.24. On arrival at the spot at 22-45 hrs it was found that one person mentioned above was selling liquor illegally from Kashmir Colony near Railway guest House to his designated customers to earn huge money for his livelihood. On seeing the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and labelled duly signed by him and also witnesses. On being asked the said apprehended person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS, as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 22-55 hrs to 23-25 hrs (seizure Total approx 7.2 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against the above noted arrested person namely Satya Das, aged 37 years S/o Nitya Nanda Das of Baribhasa, Bansh Bari PS- New Jalpaiguri, Dist.- Jalpaiguri and arrange for its investigation.
