Assault on a doctor inside the College Premises

Respected Sir, With due respect, I, Dr. Jyotirmoy Das, a house staff currently posted at the Department of Prosthodontics, Crown & Bridge [Room No. 6], North Bengal Dental College & Hospital have been assaulted inside the department in the patient waiting area during working hours, both verbally and physically around 1:40-1:45 pm, 6/8/2024 by two unidentified miscreants (One male & one female). In the commotion, a few of my colleagues, a female scavenging staff and a female faculty present at the department were manhandled and subsequently injured. They also caused damage to the departmental properties. Due to the chaos caused, the outpatient services were hampered. Therefore, considering the gravity of the situation, I would request you to look into this matter and take necessary actions at the earliest.
