With due respect , I , SMT . DIPIKA ROY BARMAN , D / O Sri Dinabandhu Barmans  
& W / O Sri Ganendra Nath Roy , presently residing at Kalamjote , Shantiniketan , P.O.  
Sushruta Nagar , P.S. Matigara , Dist . Darjeeling , in the State of West Bengal , beg to  
state that on 10.12.2010 my marriage was solemnized with Sri Ganendra Nath Roy . S / o  
Dinendra Nath Roy , resident of South Salmari , P.O. Duramari , P.S. Banarhat , Dist .  
Jalpaiguri , in the State of West Bengal , as per Hindu Rites & Customs at my parent's  
house situated at Kalamjote , Shantiniketan , P.O. Sushruta Nagar , P.S. Matigara , Dist .  
Darjeeling , in the State of West Bengal . At the time of marriage , my parents and other  
relatives and well wisher have gifted me gold neckles , earrings , bangles etc and I also  
received from my parents and other relatives other wooden furniture's , cloths , etc  
amounting to Rs . 3,00,000 / - and after marriage I have taken all the above mention gold  
and furniture's to my husband's house and after reaching at my husband's house , my  
mother - in - law , father in law , brother - in - law and my husband has taken all the above  
mention gold from me and kept those gold and valuable utensils , furniture's clothes in their  
own custody .

That after the laps of 15 days of my marriage , my husband , my mother - in- law namely  
Dinobala Roy , my father - in - law namely Sri Dinendra Nath Roy , Brother - in - law namely  
Bhugen Chandra Roy and my said husband namely Sri Ganendra Nath Roy created  
pressure upon me for bringing an amount of Rs.1,00,000 / - ( One Lac ) only from my  
parents and when I expressed the inability of my father to arrange the same , my husband  
and other in laws member created tortured upon me both physically and mentally . My  
husband used to assault me by fist and blows for demand of Rs . 1,00,000 / - only . I was  
not provided sufficient food and I was not allowed to talk with the neighbors .

But I have bear all such type of inhuman torture with a hope that one day everything will be normalized. But things got worse day by day. My husband beat me mercilessly almost every day and at that moment my mother-in-law and father-in-law without rescuing me from the clutch of my husband, they used to instigate my husband that if the demand of Rs.1,00,000/- if not fulfilled, they will kill me and they will arrange another marriage of my said husband. And thereafter I expressed all this things to my father and after hearing such type of inhuman activities by my husband and other in-laws, my father requested my husband to lead a happy marital life with me and at that time my said husband assured my father that he will rectify himself and will lead a happy marital life with me. Thereafter in the mid of year 2011, my husband started to work at Ramkrishna Pan at Matigara, P.O. & P.S. Matigara, Dist. Darjeeling, in the State of West Bengal and at that time my said husband took me there and we both started to live together at Matigara and me and my said husband stayed there till 2016 and thereafter we again came to my matrimonial house. It is pertinent to mention here that everything was running good but when I came to my matrimonial house with my said husband, all of a sudden the scenario started to change from my beyond imagination and again my said husband and other-in-laws started to create pressure upon me for demand of Rs.1,00,000/- only and when I raised voice against such type of illegal demand, my said husband started to beat me mercilessly. Thereafter again in the month of July 2022 my said husband came home at late night in a drunken condition and started to tease me and again demanded me of Rs.1,00,000/- only from my father and at that time when I refused to do the same, my said husband ramm towards me in order to kill me and when I tried to escape from the clutch of my husband, at that very moment my mother-in-law and brother-in-laws pushed me and my said husband physically assaulted me by using broom and tried to kill me and at that moment after hearing my hue and cry, some local para people came at the spot and at that time my said husband and other-in-laws member ousted me from my matrimonial house and from that time I used to reside at my paternal house situated at Kalamjote, Shantiniketan, P.O. Sushruta Nagar, P.S. Matigara, Dist. Darjeeling, in the State of West Bengal.

Sir, I have waited so many months that my husband and other in-laws will rectify themselves and again I will be able to continue my marital life with my husband and thereafter in the month of July, 2024 I came to know that my said husband got involved in extra-marital affairs with one lady named Mistu Nath, daughter of Pramod Nath of Railway Hospital Quarter, Malbazar, P.S. Malbazar, Dist. Jalpaiguri. So finding no other alternatives I came before your good self with a prayer that please investigate the above matter and take necessary legal steps against my husband and other in-laws and said Mistu Nath in accordance with law and obliged thereby.
