In producing herewith the accused person namely Smt. Puspa Basak (44 yrs), w/o- Basan Basak, resident of Kestopur, Choupukuria, PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles under proper seizure list:

1. Nineteen (19) bottles of 70° UP India made liquor i.e. "KACHI", each contains 300 ml @ Rs. 40/-

2. Twenty (20) ltrs of Chullu in two (02) plastic jars.

(Total 25.70 ltrs)

I, ASI Munna Ahmed of Bagdogra PS, S.P.C, Dist- Darjeeling, do hereby lodge this written Received complaint against the arrested accused person namely Smt. Puspa Basak (44 yrs), w/o- Basan Basak, on 13.0824 resident of Kestopur, Choupukuria, PS- Bagdogra, Dist- Darjeeling to the effect that on 13.08.2024 at at 19:40 around 17:15 hrs in course of performing patrolling duty vide Bagdogra PS GDE No. 586 dated 13.08.24, I received reliable source information that a huge quantity of liquor is stored in a hotel of one Smt. Puspa wis vide GDE NO 595 Basak at Kestopur bazaar under PS- Bagdogra and the same has been selling illegally. Accordingly, I along with SI Debabrata Kundu, SI Samik Paul, VP/01 Ansalam Kujur, VP/02 Prodip Roy & LNVF/0009 Bimla Lama left for Kestopur bazar to work out the secret source information. At around storted 17:35 hrs we reached at Kestopur bazar and had been waiting for the source indication. After a while, the BORP S source indicated the hotel of the suspect and we proceeded to hold raid at the said hotel and managed to case NO apprehend one person there and interrogated her at 17:45 hrs. On interrogation, she introduced herself as the owner of that hotel and revealed her identity as Smt. Puspa Basak (44 yrs), w/o- Basan Basak, resident of Kestopur, Choupukuria, PS- Bagdogra, Dist- Darjeeling. We disclosed our identity and the D+ 13.0824 input we had to him. She confessed that she has been stocking and selling liquor illegally from her hotel for a long time for her wrongful gain. Accordingly, I arrested the accused Smt. Puspa Basak (as noted above) at 17:50 hrs with the help of LNVF/0009 Rimla Lama of Basak. BEAU above) at 17:50 hrs with the help of LNVF/0009 Bimla Lama of Bagdogra PS, SPC after observing all legal formalities and telling her the ground of arrest and issued memo of arrest in this regard. She agreed enderned to find out the liquor which was concealed in her hotel. Then we contacted with the local people to be present as witness during the process of search, seizure, if any. Two independent witnesses namely Dinesh Shil (44 yrs), s/o- Pabitra Shil and Gobinda Das (35 yrs), s/o- Biswanath Das, both are resident of Kestopur, Choupukuria, PS- Bagdogra, Dist- Darjeeling were present as witness. Then, we conducted search at the said hotel in presence of independent witnesses and other Police witnesses. On search, the above noted liquor was recovered from the said hotel. On demand, the owner failed to produce any valid document/license for stocking and selling that liquor. The process of arrest, search & seizure was made in between 17:50 hrs and 18:45 hrs on 13.08.2024. The entire process of search & seizure is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a

Officer in charge Therefore, I request that a specific case under proper section of law may kindly be started against the arrested accused person namely Smt. Puspa Basak (44 yrs), w/o- Basan Basak, resident of Kestopur, Bagdogra Champukuria, PS- Bagdogra, Dist- Darjeeling (not verified) and arrange for its investigation.
