- I, SI Tanmay kundu of NJP PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Sushanta Saha (50) S/o Lt. Subhash Ch Saha of Kanchanbari PS- New Jalpaiguri, Dist.- Jalpaiguri under arrest along with following seized articles;
  - 1. 09 (nine) Nos sealed Bottles of Himalayan gold country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.

I am submitting a written complaint against the above noted accused person to the effect that on 13.08.24 night at 00.05 hrs received source information that one person was selling Liquor illegally from Canel road near Jorapani Bridge under PS- New Jalpaiguri, Dist.- Jalpaiguri to its customers without any valid license. Accordingly I informed the matter to the duty officer of NJP PS and O.C. NJP PS and as per his instruction myself alongwith ASI Nilam Swarnakar C/1462 Sajan Tamang, VP- 13 Jamirul Islam all of NJP PS, SPC left for Canel road to verify the veracity of information vide NJP PS GDE No. 732 Dated-13.08.24. On arrival at the spot at 00-30 hrs it was found that one person mentioned above was selling liquor illegally from Canel road near Jorapani Bridge to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in presence of witnesses I recovered the above noted articles from his possession and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 35 BNSS as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 00-35 hrs to 00-55 (seizure Total approx 5.4 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against one arrested person namely Sushanta Saha (50) S/o Lt. Subhash Ch Saha of Kanchanbari PS- New Jalpaiguri, Dist.-Jalpaiguri and arrange for its investigation.
