With due respect I would like to inform you that I, Samrat Barman, lives in Mou Villa, Bomaful Sarani Nabagram west, Siliguri - 734007. My wife Nibedita Modak Barman was returning from her work yesterday evening at 4:00 PM in Rajib More, Babupara collided with a school bus, the number of the school bus is WB 73 E 3133. After the clash, she was taken to Siliguri Hospital with the help of the bystanders and the police. After that she was then taken from Siliguri Hospital to Neotia Superspeciality Hospital, where she died during treatment at around 8:30 PM, 13/08/2024.

I humbly request you to take appropriate legal action against the driver and owner of that school bus.
