Sir,

With due respect I like to draw your kind attention that One Ms. Piyali Bhownik, Dio Sri Tapash Bhownik, Milan Pally, Gopiti Apptt. Mukunda Das Sarani, Siliguri friend of my son Sri Anagh Poddar age 29 yrs, she enticed and trapped our family that she can arrange to provide our family a new F.L. Shop with bar licence at Siliguri through one influential person Mr. Souvik Mukherjee, S/o S.N. Mukherjee Green Lodge, Opp Gosala More, Milan Pally, P.S. Siliguri – 734005 provided I pay Rs. 19,50,000/- (Rupces Ninteen lakhs fifty thousand) only. Mr. Mukherjee claimed himself as an IPS officer and both piyali and said Mukherjee had a close nexus and they had cheated many persons which we came to know later on.

Sub : FIR against Piyali Bhowmik & Souvik Mukherjee.

As such the said Piyali Bhowmik is our family friend and we need permanent settlement of our only son, Anagh Podder we became puzzled and scape goat. As per Piyali's instruction I had paid Rs. 17,50,000/- (Rupees Seventeen lakhs fifty thousand) only and Rs. 2,00,000/- cash phase wise through my SB A/c No. 192901001590 from LC.L.C. Bank, S.F. Road, Siliguri to the current A/c of Ms. Piyali Bhowmik (Prop of Piya Creation) vide A/c No. 917020085478320 Axis Bank, S.F. Road, Siliguri. The entire transaction were made in between 2021-2022 which is evident from our statement of accounts details attached.

In the mean time, the said Piyali tried to avoid us by playing tricks as we chased for the deal. We had also contacted the said influential middleman Mr. Souvik Mukherjee over phone and Whatsapp. He also assured us for the same. We had kept his Whatsapp massage.

Therefore, in March 2022 Mr. Mukherjee had sent a letter regarding recommendation some names who had allotment F.L. OFF shop and bar licence. The said letter dt. 8th March issued by Central Board of indirect Taxes and Customs. When we objected after enquiry, licence can be issue by only Govt. of W.B. thereafter he again had sent another letter dt.22/04/2022 for allotment of F.L. off shop and bur licence in my name issued by Deptt. of Excise, Govt. of W.B. When we enquired about the said licence we came to know that said letter is fake and vague Ms. Piyali & Mr. Souvik Mukherjee cheated us & committed criminal breach of trust etc.
