I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 6/7 persons to the effect that on the night 14.08.24 at 00-05 hrs received secret source of information to the effect that some miscreants armed with deadly weapons with one Car assembled in a dark place at Canel road, Sipaipara near DPS School under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and as per your kind direction myself alongwith, ASI Nilam Swarnakar, ASI Sudarshan Mandal, C/1462 Sajan Tamang, VP-13 Jamirul Islam CV-297 Putul Roy, CV-306 Biswajit Roy, CV-824 Niru Kumar Yadav left from PS vide noted in NJP PS GDE No. 793 dt. 14.08.24 and called night mobile van officer PSI Ramkrishna Mahanto and force for Canel road Sipaipara to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 00-20 hrs and stopped out vehicle at a considerable distance from that place and we started walking towards the said place and we reached near the place and found a group of 11/12 persons with one Car assemble and gossiping in a dark place at that place. We started approaching them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we intercepted the said Car having No. BR-06-CD-0637 and could able to apprehend the O5 (five) persons noted above who are sitting inside the said car and the others 6/7 persons managed to flee away from the spot. On interrogation they disclosed their identity which is not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Sipaipara under NJP PS. Thereafter all the apprehended persons were searched and also the said Car. During searching I found and recovered the above noted articles from their possession as well as from the said Car at Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in videography as per provision of law and due to late night could not found any independent witness to present at the time of search and seizure. Accordingly I arrested the above noted accused persons u/s 35 BNSS. The all persons were arrested with proper memo of arrest. The seizure and arrest was made in between 00-25 hrs to 00-50 hrs.
