Sub - Complaint against the below named miscreants and Land Mafias for commission of offences of attempt to murder, of grivieous hurt and assault, of dishonestly inducing delivery of property, of forgery of documents and for using the forged document(s) as genuine and thus praying for your kind intervention and necessary protection for carrying out the boundary wall construction work.

Sir,

I, ARATI AGARWAL, Wife of Sri Devesh Agarwal, Residing at B-6, Basundhara Abasan, P.O. Satellite Township, P.S. NJP, Dist - Jalpaiguri, Pin - 734015, wish to draw your kind attention to the unlawful activities of the Land mafias, who are attempting to forcibly seize my purchased land situated at Putimari, Fulbari through orchestrated illegal means. For your better understanding I want to portray the following facts:-

- I am the absolute owner in possession of 52 Kathas of land appertaining to and forming part of R.S. Plot No. 640 (Corresponding L.R. Plot No. 468), comprised in R.S. Khatian No. 875 (Corresponding L.R. Khatian No. 6629 & 6633) of Mouza Binnaguri, Sheet No. 11, under P.S. New Jalpaiguri, in the District of Jalpaiguri, by virtue of two registered deeds of sale, one being No. I- 6441 for the year 2023 and another being No. I- 6438 for the year 2023 both registered at the office of the A.D.S.R, Bhaktinagar, Dist - Jalpaiguri.
- That after having acquired the said land I recorded my name in the relevant record of rights, and the concerned BL&LRO after verifying my title and physical possession over the aforesaid land opened two L.R. Khatians being No. 6629 & 6633 in my name.
- In our area, the surging land prices have captured attention of both land mafias and influential local politicians, as a result of which whenever I try to start some sort of construction work on my aforesaid land the below named miscreants constantly try to trespass into my land with their aids and associates accompanied by arms and sharp deadly weapons and also threatened us to stop the

construction works, or to face dire consequences. The below named miscreants no. 1 & 2 are very influential politicians belonging to the camp of the ruling party of the state and all illegal acts and activities are planned under their leadership. Previously the miscreants even entered into the land and tried to cut earth therefrom, had stolen construction materials therefrom and they had also threatened us showing deadly firearms that I need to pay them a huge sum of money to the tune of Rupees One Crore or else my family would have to lose our lives. This has happened with us several times. I had previously informed you about such incidents and the inconveniences caused to us, but unfortunately found no commendable support from your end.

That the below named miscreants have hatched a conspiracy to grab my land. The below named miscreants no. 1 was the Anchal President of TMC and the below named miscreants no. 2 is the current Upo Pradhan of Fulbari-II G.P. and they are using their political influences to create pressure upon me in order to induce me in handing over my property to them or for giving them a huge amount of extortion money.

That in furtherance to their previous illegal acts, yesterday i.e. on 05/08/2024 at around 11 a.m. in the morning, I along with my husband visited my aforesaid land along with my contractor and some masons with the intention of constructing a boundary wall on my said land. While we were engaged in the preliminary work, the below named miscreants along with a group of approximately twenty individuals arrived at the site and started instigating trouble, so that they can forcefully take possession of my land.

Thereafter the assailants, without any provocation, started assaulting us using deadly weapons like thick bamboo stems and sharp daggers. Many of us got seriously injured and were forced to stop the work. Even though I and my husband asked them to stop such assault the assailants, continued the assault with clear intention to kill my people and the miscreant no. 1 aggressively came towards me and held my neck tightly in order to take away my life. Thereafter few of them took out and brandished deadly firearms to intimidate us and restrain our movement by creating an atmosphere of fear. In such situation the miscreants' no. 1 & 2 came forward and threatened us that now we need to pay them One Crore Rupees within a week or else they shall end our lives. Thereafter due to interference of the passerbys and motorists the miscreants had fled and we managed to escape that dreadful situation. Due to the actions of the accused persons, there was a significant disturbance to the public peace in the area and we have sustained heavy injuries due to the attack.

These actions of the below named persons have caused significant distress and anxiety to me and my family. Me and my family are feared that the continued harassments and threats by the below named persons may pose a grave risk to the safety and well being of my family.

In addition to the physical violence, the accused persons have forged documents related to the property in question with the intention of dishonestly inducing me to deliver the property to them.

I, therefore, request your good office to treat this written complaint as an FIR and book the below named miscreants under relevant sections for commission of offences of attempt to murder, of grivieous hurt and assault, of dishonestly inducing delivery of property, of forgery of documents and for using the forged document(s) as genuine and also kindly provide me all necessary protection and assistance for carrying out the boundary wall construction on the aforesaid land.
