Respected Sir,

I SMT. DARSHANIYA SAHANI, Daughter of Lt. Jayalal Sahani, resident of Munshi Premchand Sarani, Prakash Nagar, Ward No. 43 of S.M.C., P.S. Bhaktinagar, District - Jalpaiguri, beg to state that I am the owner-in-possession of a land measuring about 1 Katha 2 Chattaks with 12 years single storied pucca residential building measuring about 400 sq. ft., recorded in R.S. Khatian No. 429 corresponding to L.R. Khatian No. 164, R.S. Plot No. 66 corresponding to L.R. Plot No. 28, within Mouza - Dabgram. J.L. No. 2, R.S. Sheet No. 6, P.S. Bhaktinagar, District - Jalpaiguri by virtue of a registered Deed of Gift being no. I-8683/2022, Book No-I, Volume No. - 0711-2022, Pages from 201314 to 201329, registered on 16/09/2022 at the office of A.D.S.R. Bhaktinagar, District - Jalpaiguri. Thereafter being owner in possession, I am possessing the aforesaid land free from all encumbrances and charges whatsoever. It is to be stated here that today on 14/08/2024 at around 2.30 P.M. when construction work was going on at my aforesaid land, for surrounding the said land by constructing brick build boundary walls through labourers, my sisters namely Shila Sahani, Wife of Bechan Sahani and Mila Sahani with her husband namely Munna Sahani along with their associates appeared at my aforesaid land and started to create ruckus. Without spending any words most forcefully they broke the boundary walls as constructed in and over the said land. On protest they physically assaulted my mother namely Dukhni Sahani as well as the labourers who were engaged therein. On getting information over phone I along with my husband rushed to the spot wherein the aforesaid persons along with their associates threatened as well as addressed filthy languages to me and my husband. On my query they demanded 5 lakhs rupees as extortion money for any sort of construction in and over my registered land. On my shout they left the place by threatening with dire consequences. During the said criminal activities they stole some building materials such as cements, bricks etc. worth Rs. 60,000/- (Sixty thousand) from my land. There is every apprehension of their future attempt of criminal act if I continue construction in and over my said land. So I am seeking protection from the aforesaid persons.

I therefore request your goodself to do the proper investigation of the above said matter & take appropriate legal action against 1) Shila Sahani, Wife of Bechan Sahani, resident of Mallaguri, P.S. Pradhan Nagar, District - Darjeeling, 2) Mila Sahani, Wife of Munna Sahani and 3) Munna Sahani both are resident of Prakash Nagar, Ward No. 43 of S.M.C., P.S. Bhaktinagar, District - Jalpaiguri and their associates. Thereby I shall be highly obliged to you.
