With due respect I, Smt. Nisha Mahato, Wife of Sri. Suman Basak, Fourth Floor, Bapi Apartment, Suryasen Street, Dist- Darjeeling, P.O- Rabindra Sarani, P.S- Siliguri, West Bengal, PIN- 734006, would like to inform you as follows:

- That I am legally wedded wife of Sri. Suman Basak, S/o Mrs. Sima Basak and Late. Manik Basak. Our engagement was held on 12th march, 2023 in the presence of both families, relatives and our well-wishers. Our marriage was registered on 05th October, 2023 in the Office of the Marriage Registrar, at Kabi Jasimuddin Sarani, South Deshbandhupara, Siliguri, District- Darjeeling, West Bengal, PIN- 734001 under Special Marriage Act, 1954 in presence of both the families. And that, our marriage was solemnized socially on 31st January, 2024 in presence of both the family members and our well-wishers.
- 2. That at the time of our marriage, my father voluntarily gifted me and my husband one Diamond Ring, gold ring (2 pairs), one gold chain of approx. 10-12 grams, silver jewelleries, and gold jewelleries, furniture as Streedhan, and the cash received from relatives, friends and well-wishers but, my mother-in-law always wanted a good amount of dowry which she demanded at the time of our marriage.

3. That, after marriage we started cohabiting as husband and wife in my matrimonial home situated in the above noted address. That our marriage was a love marriage, and I was treated well in my matrimonial house for around 2 months. But, suddenly after 2 months of our marriage, I noticed some behavioural changes in my husband and my mother-in-law. Nde (14 Woman) That my mother-in-law started demanding me dowry and when I refused for the same my mother-in-law used to provoke my husband by stating that she is non Bengali girl, the situation would have been different if you would have married a Bengali girl, as Nisha is Bihari and she does not know anything about our culture and customs, and she does not value our caste and community, it would be better for us if you leave her and marry another Bengali girl so that I can live peacefully under the same shelter with the girl / daughter-inlaw who is more prone to our culture and customs. (1/2)

That after such incidents and induced by the words of my mother-in-law, my husband stopped talking to me. That one day after such incidents, I prepared the breakfast and served in front of my husband but he ignored me as if I have committed a crime, then i stepped towards him and said your breakfast is ready, but he again ignored my words and left home for office. I tried to call him but he did not receive my phone call and after he returned back to home in the evening, I asked him about the reason of his anger and ignorance attitude towards me, he replied that he do not find our marriage interesting anymore and he said that his mother is a single mother and he does not have his father and so it is his mother's wish that I should bring some dowry in my matrimonial home. On hearing such wish from my husband, I shockingly replied that you had promised me to marry me, as we were in relationship for more than 2 years and you always had an intention GURI POLICE COMMISSIONERATETRY me without any dowry, but suddenly what happened to you? Why are you asking me for such ill practices which is also against the law and order? Why are you demanding

- That thereafter, my husband started ignoring me and my mother-in-law used to torture me both mentally and physically. That whenever I complained about the same to my husband, he either used to ignore any conversation with me or he used to become aggressive and uses to physically assault me. One day, I called my father to talked with my husband and my mother-in-law, he also gave two sets of gold chain to my husband and convinced him to take care of our newly wedded life. Thereafter the situation was under control.
- 6. That on 11/06/2024, I asked my husband namely Suman Basak to drop me to my paternal home situated at Ram Krishna Road, Ashram Para, Siliguri, Ward No.14, under Siliguri Municipal Corporation, P.O and P.S- Siliguri, District- Darjeeling, as on 12/06/2024 the jamaisosti ceremony was arranged at my father's home. That my husband took me to my father's house but he did not enter inside the house and reasoned me that he was getting late for his office so he asked me to enter alone inside the house and he promised me that he will come on 12/06/2024 at about 10:00 am in the morning before the jamaisosti ceremony begins.
- 7. That on 12/06/2024 everyone in my paternal home was ready and excited for the ceremony of jamaisosti celebration but my whole family was shocked to see that my husband did not come to attend the ceremony and it was the very first jamaisosti ceremony after our marriage. On being worried about non arrival of my husband to my father's home I called him but he did not picked up my call and my parents also tried to call him and ask the reason whether he is safe or not? Or whether is there any work load due to which he might get late for ceremony but it was shocked to see that he did not pay any heed towards the phone calls made by us.
- 8. That on 17/06/2024, I went back to my matrimonial home but very shocking incident took place whereby my mother-in-law was alone in the house and she stopped me and did not allow me to enter the house and asked me to leave the house. On being shocked and surprised by the behaviour of my mother-in-law, I asked my husband to come to home as early as possible, but he abused me in filthy language over phone call and threatened me not to enter the said matrimonial home otherwise he will kill me.
- 9. Thereafter, I called my father to come to my matrimonial house and informed him about those heinous behaviour of my mother-in-law and my husband towards me, my father came to my matrimonial house and inquired about the reason of their anger and issues for which I was being refused to enter the said matrimonial home but, it was again shocked to see that my mother-in-law after seeing my father became furious and started shouting at my father and tried to create bad impression of my father in the society, she also started to make false allegations of molestation against her by my father. That my husband also arrived on the spot and my mother-in-law slapped on the face of my father in front of my husband and abused him in filthy languages. That my husband also used abusive and filthy language to me and my father and when I protested, my husband and mother-in-law started physical assault upon me by using fist and blow and by pulling my hair, my husband pushed me on the ground and kicked me and teared my kurti which I was wearing at that time.
- 10. That finding no other alternative, I returned back to my paternal home with my father at Ram Krishna Road, Ashram Para, Siliguri, Ward No.14, under Siliguri Municipal Corporation, P.O and P.S- Siliguri, District- Darjeeling, after such incidents I tried my level best to communicate with my husband and my mother-in-law but, they refused to talk with me over phone calls or even in physical mode. That it is pertinent to mention here that, at

my gifts that I had received at the time of our marriage but, he slapped me on my face and said those gifts does not belongs to you, and now I don't know whether my gifts and streedhan is safe or not which I had kept in my locker.

- 11. That on 17/06/2024, I informed about the said misbehaviour that has happened with me and my father at my matrimonial home by my husband and my mother-in-law to the Siliguri office Station and on the aid and advice of the Police Officers we went to my husband's office addressed at opposite of Eidhan Market Auto Stand, Siliguri, West Bengal to agree to settle the matter, but, the it is pertinent to mention here that my husband did not otherwise he will lodge false case against me and my family members.
- 12. That I tried to amicably settle the dispute by meetings in presence of the community members and the local councillor but, they did not come in any meetings organised for the settlement of the dispute. That I also talked with the family counselling group situated at Indian Red Cross Society Building, Near Children Park, Siliguri so that they can help us in this regard. That on 31/07/2024, the family counselling group informed both the parties about the schedule of the meeting but, my husband and my mother-in-law did not come to settle the dispute. That again on 01st August, 2024 the family counselling group contacted my husband and my mother-in-law to attend the counselling session but they refused to attend such meetings and counselling sessions in harsh words.
- 13. That it is pertinent to mention here that my husband promised to marry me and our marriage is a love marriage accepted by both the families and legal in the eye of law but, I am disappointed with the sudden changed behaviour of my husband only after 2 months of our marriage whereby, we were already in relationship since more than 2 years. That my husband never complained me that whether he has any problem with me the only thing that he confessed that he wanted some dowry for which I refused to agree but later on, my father gave him 2 gold chains as per my husband demand. That I am very shocked with the changed behaviour of my husband and my mother-in-law, they had tortured me both mentally and physically only after two months of our social marriage and they are not ready to take me back to my matrimonial home, so they are entitled to get punished in the eyes of law for committing such heinous behaviour, torture and demanding money and cheating with me because of which I got married to Mr. Suman Basak.
- 14. That I tried my best to resolve this union of marriage but all the attempts were failed so I hereby request you to take strict legal action against both the alleged persons as they have committed the offence of cheating, fraud, molestation, harassment, dowry, and unbearable torture. I hope your good office shall help me in this regard and take strict legal action against them.
