In producing herewith 05 (Five) arrested accused persons namely (1) Ashraful Islam-19yrs s/o Abdul Rashid of Kokila, Part-1, PO Kokila, PS Abhayapuri Dist Bongaigaon, Assam (not verified) (2) Abu Rayhan Ansari-28yrs s/o Jakir Ansari of Vill Chendaidih-Koltar PO Dhabna, PS Jamtara Dist Jamtara Jharkhand (not verified) (3) Asfak Ansari-20yrs s/o Abdur Rahaman Ansari of Chendaidia Koltar near primary school PO Dhobna PS Jamtara Dist Jamtara Jharkhand (not verified) (4) Afroj Ansari-30yrs s/o Lal Mohan Ansari of Vill Chendaidih-Koltar PO Dhabna, PS Jamtara Dist Jamtara Jharkhand (not verified) (5) Tabis Rehan -19yrs (not verified) s/o Masud Alam of Chendaidia Koltar near primary school PO Dhobna PS Jamtara Dist Jamtara Jharkhand arrested on 15.08.24 u/s- 35(1) of BNSS along with following seized articles viz: -

1] one Improvised iron made Fire Arms fitted with trigger, which barrel in length approx 5 ½" and butt in length approx 5 ½" with one round live ammunition was recovered from the possession of Tabis Rehan which was kept in his left waist.

2] One iron made KHUKRI measuring about 17 inch with butt (approx) kept with wooden cover recovered from the possession of accused Afroj Ansari which was kept on his right hand.

3] One iron made crowbar length in 17" recovered from Abu Rayhan Ansari

4] One steel made kanchi with plastic butt 5 ½" in length kept in travel bag

5] One steel made knife with plastic butt 7" in length kept in travel bag

I, ASI Debasish Das of Siliguri Police station under Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that, on 14.08.24 at 00.10 hrs received a sources information that 05/06 youths have assembled at Sarbahara colony, New Cinema road under Siliguri PS for making preparation to commit dacoity in a jewellery shop at new cinema road (Sona patty) under Siliguri PS area. The fact was diarized in G.D vide Siliguri PS GDE No.769 Dated 15.08.24 Subsequently after sharing the information with my superiors and as per their direction, at 00.15 hrs myself along with SI Srimanta Chatterjee, ASI Subir Sen, ASI Debasish Das, C/160 Soumen Sarkar, CVF/622 Ramanath Barman along with ASI Barun Kumar Dey & ASI Srijit Paul with his force (Van officer K-21(III) & CS-III) kits left for the place to work out the information. This refers to Siliguri PS GDE No-770 dated 15.08.24.

We reached at 00.25 hrs on 15.08.24 and waiting there, subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from that Place. Sensing the police has cordoned off, they tried to flee away but on hot chase we managed to apprehend above noted 05 (five) accused persons along with seized articles as mentioned above. On interrogation the accused persons admitted that they have assembled there to commit dacoity in a jewellery shop of new cinema road under Siliguri PS.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the Witnesses and acknowledged by the accused persons. (The whole seizure was made in between on 15.08.24 at 00.50 hrs to 01.40 hrs) Thereafter, I arrested the above noted accused persons u/s 35 (1) of BNSS under proper memo of arrests duly signed by the accused persons and also supplied the copy of arrest memo to them. The process of search & seizure has been audio & video graphed at the PO.


I accordingly brought the arrested accused persons along with seized articles at Siliguri Police Station for further investigation. During interrogation, they are stated that they are gathered there to commit Dacoity in a house at Siliguri PS area with all equipments. They are come from Jamtara, Jharkhand and staying at Siliguri since few days to commit Dacoity..

Hence, I pray before your good self that, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (1) Ashraf Islam-19yrs s/o Abdul Rashid of Kokila, Part-1, PO Kokila, PS Abhayapuri Dist Bongaigaon, Assam (not verified) (2) Abu Rayhan Ansari-28yrs s/o Jakir Ansari of Vill Chendaidih-Koltar PO Dhabna, PS Jamtara Dist Jamtara Jharkhand (not verified) (3) Asfak Ansari-20yrs s/o Abdur Rahaman Ansari of Chendaidia Koltar near primary school PO Dhobna PS Jamtara Dist Jamtara Jharkhand (not verified) (4) Afroj Ansari-30yrs s/o Lal Mohan Ansari of Vill Chendaidih-Koltar PO Dhabna, PS Jamtara Dist Jamtara Jharkhand (not verified) (5) Tabis Rehan -19yrs s/o Masud Alam of Chendaidia Koltar near primary school PO Dhobna PS Jamtara Dist Jamtara Jharkhand and arrange for its investigation.
