1. That I, Masud Alam working as an
labourer / helper staff in 'Jagat' hotel
situated in Air-view more Siliguri since
2021.
2. That I was being paid a salary amount
rupees 11,000/- per month for my work
as an staff in the said hotel by the
owner's of the hotel namely - Santosh
shah and Kanaiya shah

3. That for the last one month the Owner's of the hotel did not paid the Salary amount to me even after repeated request towards the owner's of the said hotel.

4. That on the last night dated 6th Aug of 2024 at about 3 am I was in the hotel premises along with the other labourer's of the said hotel namely 'Jagat' hotel, the other labourer's / helper namely Dilip and Debdas suddenly trying to snatch my mobile phone when I refused to give them my mobile phone, they forcefully snatched my mobile phone from my custody. On that particular of time upon the instruction of the Owner's of the said hotel namely Santosh shah and Kanaiya shah, they started hit me with - marble stone, iron rod, sharp knife and Hammer and they attempted to kill me and they repeatedly hitting me with marble stone and iron rod for that reason my head was fractured and there was heavily bleeding from my face, eyes, head

and other body parts. I got grievous injuries over my body.

5. That after hitting me they kicked me from the hotel premises and I was there till the morning with that serious condition and I was totally senseless. Then some of my friends from 'Prasad' hotel took me in Srigiri Hospital, where I started taking my treatment and advice me for further immediate treatment.

I, therefore request you to take immediate and necessary legal action against the aforesaid persons so that I shall be highly obliged to you.
