begs to inform you that my marriage was solemnized
with Sri Jaiprakash Sahani S/O Sri Nareesh Sahani
under Hindu rites & rituals, but since after my marriage
the above noted relatives of my husband used to torture
me to evict us from our house.

Sir, on dt. 08.08.2024 at about 10:00am, the
above noted my in-laws, started abusing my husband
namely Jaiprakash Sahani & O Sri Nareesh Sahani and
my matrimonial house at Ganga Nagar, and when I
protested, they beaten us brutally and my brother-
in-law namely Parmeshwar Sahani, & O Sri Nareesh Sahani
drove me away in my room and closed the door
and turn off my light and disrobed me and tried
to rape me and my other-in-laws poured kerosene oil
on my body and tried to burn me, at that time my
sister namely Kanti Devi (23) W/O Sri Dharmendra Singh
of Coalipara (Bijendra Nagar), Ward No. 1 (Near Primary
Deshbandhu school), P.O. P.S. - Siliguri, entered into my
room and saved me from their hands.

Sir, I received severe injury on my person and
treated myself at Siliguri Distt. Hospital.

So, please take necessary action against above
noted alleged persons.
