Sir,  
In producing herewith five (05) accused persons namely (i) Mukesh Biswakarma (27) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim (ii) Anmol Tamang (M-20) S/O Lt. Maniraj Tamang of Kowlay, P.O. Krishna Nagar, P.S. Mirik, Dist. Darjeeling (iii) Gopal Karmakar (22 yrs) S/O Late Bimal Karmakar of Pati Colony, Road No-02, PS- Pradhan Nagar, Dist. Darjeeling (iv) Kamaljeet Singh (30) S/O Late Paramjeet Singh of Devidanga, Manoj Busty, PS. Pradhan Nagar, Dist. Darjeeling (v) Biki Sabani (23 yrs) S/O Late Kapil Sabani of Hatat Colony, Tikoa Para, Ward No-28, PS- Siliguri, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) One (01) black & yellow colour touch light, (ii) One (01) iron made rod (Sabot) measuring 17.5 inches approx in length, (iii) One (01) iron made Hammer with its wooden made handle measuring 10 inches in length, (iv) One (01) iron made sharp cutting weapon called as 'khukri' measuring 10 inches approx in length including its wooden butt, (v) One (01) iron made sharp cutting weapon called as 'Hasua' measuring 18 inches approx in length including its wooden butt, (vi) One (01) iron made sharp cutting weapon called as 'Hasua' measuring 22 inches approx in length including its wooden butt and (vii) One (01) multi colour nylon bag. ASI Prabal Sarkar of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted five (05) arrested accused persons and their 06/07 unknown associates who involve in this crime to the effect that on 11.08.2024 at 00.10 hrs received a specific source information that about 11/12 miscreants assembled in an abandon railway quarter of BRI Colony, under PS- Pradhan Nagar, Dist. Darjeeling equipped deadly weapons and were taking preparation for committing dacoity at Gate Bazar and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 612 dated 11.08.2024. As per your kind order and direction, at about 00.15 hrs, I accompany with SI Goutam Mallik, SI Bandhan Roy, ASI Biplab Kr Das, C/1415 Chandan Basak, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for BRI Colony under Pradhan Nagar PS, Dist. Darjeeling by Govt. Vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. This refers to Pradhan Nagar PS GDE No. 613 dated 11.08.2024. I informed one vedigrapher namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist. Darjeeling to requested him to come to BRI Colony, Gate Bazar for the purpose of vedigraphy if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer SI Abu Taleb of Pradhan Nagar PS and requested him to come to BRI Colony, Gate Bazar to accompany with us. We arrived at BRI Colony, Gate Bazar and contact with my source while he stated that the miscreants assembled in an abandon railway quarter, BRI Colony, under PS- Pradhan Nagar, Dist. Darjeeling. Then, I contacted with independent witnesses namely (i) Rajesh Sah (24 yrs) S/O Late Sambhu Sah of Devidanga, near Fasia 1, Champasari, PS. Pradhan Nagar, Dist. Darjeeling and (ii) Kartick Sah (25), S/O Late Chandrika Sah of Gate Bazar, BRI Colony, PS- Pradhan Nagar, Dist. Darjeeling and I informed them regarding the information and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. In the mean time night RT van Officer SI Abu Taleb along with his force C/- 1503 Bidhan Paramanick and the above named vedigrapher arrived there and accompany with us. I briefed him and his team properly.

Thereafter, being pointed by the source from a considerable distance we noticed that some persons assembled in an abandon railway quarter, BRI Colony, under PS- Pradhan Nagar, Dist. Darjeeling and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted five (05) accused persons while 06/07 others managed to fled away from the spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered one multicolour nylon bag containing the above noted weapon of offence from SI No. (i) to (vi) from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such dead hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing dacoity at Gate Bazar and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their possessions under proper seizure list in between 00.45 hrs to 01.10 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeelin as per norms of BNSS and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit dacoity in a nearby affluent area at Gate Bazar and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Mukesh Biswakarma (27) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim (ii) Anshul Tamang (M-20) S/O Lt. Maniraj Tamang of Kowlay, P.O. Krishna Nagar, P.S. Mirik, Dist. Darjeeling (iii) Gopal Karmakar (22 yrs) S/O Late Bimal Karmakar of Pati Colony, Road No-02, PS- Pradhan Nagar, Dist.- Darjeeling (iv) Kamaljeet Singh (30) S/O Late Paramjeet Singh of Devidanga, Manoj Busty, PS. Pradhan Nagar, Dist. Darjeeling (v) Biki Sahani (23 yrs) S/O Late Kapil Sahani of Hatat Colony, tikia Para, Ward No-28, PS- Siliguri, Dist.- Darjeeling and others 06/07 unknown miscreants and arrange for its investigation.


