That said Mr. Abhijit Paul (Rana), has been working with us as a cylinder delivery boy since last few years. Recently, some of our customers informed us that since couple of days said Mr. Abhijit Paul (Rana) during his service doing some irregularities with the delivery of LPG cylinders, unethical cylinder lifting from our customer's premises and at the same time he also demanding money from them for getting undue advantages. After having got such information, he has been verbally cautioned by us in many times. In this situation he assured us not to do such activities again. We thus, given him a last chance to continue his work after having got a written assurance from him (attached herewith).

But, in spite of that it was found that said Mr. Abhijit Paul (Rana) is still repeating the same malpractices and offences having lifting of filled and empty cylinders from consumer's premises and sometimes demanding cash money illegally as alleged by our LPG customers (attached complaint letters from the concerned consumers).

Under the above circumstances having followed such repeated incidents, we have suspended him indefinitely from the duty of delivery of LPG cylinders on and from 14.08.2024 onwards. However, we presumed that he may continue to harass our consumers using his previous identity as our authorised delivery man, which may be pull down our business reputation.
