Sir,

With due respect I Smt. Chandra Sarkar, Wife of Soumik Sarkar, resident of South Bharatnagar, Atheletic Club, Siliguri, District – Darjeeling, now presently residing at fokdai bari, Police Station – Bhaktinagar, District – Jalpaiguri, would like to lodge this written complaint before you on the following facts.

That on 11/06/2014 my marriage was solemnized and the same was registered with Sri. Soumik Sarkar, son of Late. Sunil Chandra Sarkar, resident of South Bharatnagar, Atheletic Club, Siliguri, District – Darjeeling and the social marriage according to Hindu rites and customs was solemnized on 24/11/2014.

My marriage was an arrange marriage and on the time of negotiation they have demanded gold ornaments and different house hold furniture and other valuable things for themselves.

That after my marriage I started to live at my husband's house with my husband Sri. Soumik Sarkar. That after starting my conjugal life I realized that my husband were not happy with the jewelry, household items and even he was not happy to marry me as my skin colour is dark in nature. He used to taunt me constantly and insult me, my parents and brother & sister for not getting the jewelry, house hold items and other items as per his standard. Soon I realized that my husband is very angry, aggressive, head strong person who also taunt me in regards of my complexion, beauty and also he was very dissatisfied with the items given in my marriage by my parents.

That within few months I found that my husband became very aggressive and most of the time I was forced to do all house hold works. My husband never bothered to care about me even when I was pregnant.

That in the year 2016 on 14th February my son was born namely Sagar Sarkar. Thereafter I became subject matter of regular physical and mental torture, abuse, pain on account of by my husband. My husband started to torture me in various inhuman ways and used to pick up quarrels with me

on very small family affairs. My husband caused extreme cruelty upon me and he told me not to mix up with any relatives and even with neighbors.

I was under tremendous depression and was not allowed to meet or call my parents, my husband threatened me with dire consequences, and he confiscated my mobile phone, and also broke open my Almirah and took away all my stree dhan- my gold ornaments, cash and other valuables.

That my husband used to come home drunk and was also accustomed to other drugs and intoxicated substances and with the passage of time my husband started consuming alcohol at home also. That as and when I being his wife, pleaded and asked my husband to stop drinking, every single time he ignored my request and instead he hit me with fist and blows and thereby tortured me mentally and physically. My husband even doesn't allow me to take day to day basic essential meals for survival for a considerable period of 5-6 days.

He forcefully kicked me out from his house with my child and I went with my mother into my maternal house as a last resort which is situated at fokdai bari, Ashighar, Jalpaiguri- 735135. Then my husband continuously made a phone call to me, my mother and sister, and threatened us with dare consequences which shall lead to Physical injury. My mother tried to convince him to save my conjugal life but he pushed me and drove me out again from his house.

So therefore I request you kindly acknowledge this complaint and lodge FIR against the aforesaid accused person i.e., my husband as per provision of law and also do needful justice in favour of me and my child.
