With due respect, I am producing herewith the following arrested accused persons namely (i) Mahabul Alam (32 yrs) s/o Abdul Rasid of vill. Chocha, PS. Baishi, Dist. Purnea (Bihar) (ii) Md Sayed (29 yrs) s/o Farjun Ali of vill. Bhagaban pur, PS. Dalkhola, Dist. Uttar Dinajpur along with following under proper seizure:-

1. One truck having registration number BR 11-T/4166 loaded with 13 (thirteen) numbers of big size Buffalo and 12 (Twelve) numbers of Buffalo calf.
2. One truck having registration number BR 11-S/7301 loaded with 13 (thirteen) numbers of big size Buffalo and 11 (Eleven) numbers of Buffalo calf.


I, SI Chabilal Sinha of NJP P.S. Siliguri Police Commissionerate, do hereby lodge this written complaint against the above noted drivers of the above noted seized vehicle to the effect that on the night of 19/20-08-2024 at about 04.30 hrs while I was performing night van patrolling duty under NJP PS area, with C/1520 Samir Adhikary and C/ 733 Alope Das of NJP PS, after receiving a source information regarding illegal transportation of Buffalos and as earliest informed OC/PS regarding the information, and as per his direction intercepted the above noted vehicles bearing BR 11-T/4166 loaded with 13 (thirteen) numbers of big size Buffalo and 12 (Twelve) numbers of Buffalo calf and one truck having registration number BR 11-S/7301 loaded with 13 (thirteen) numbers of big size Buffalo and 11 (Eleven) numbers of Buffalo calf at Fulbari Bye Pass more under New Jalpaiguri PS area which was coming from Ghosh Pukur side towards Assam. On being asked the drivers above named disclosed their identity as above and stated that they were carrying the Buffalos with calf from Purnia Bihar to Assam. On demand they could not show any valid documents for being possession of the cattle nor any live stock permit of the above noted Buffalos loaded in the said vehicles. Even no any valid papers in r/o of the vehicles in which the buffalos were loaded. It was also found that the Buffalos and calfs were in such manner of position causing to unnecessary pain and suffering to the cattle. Accordingly the above noted I arrested the above noted accused drivers and both the vehicles were seized under proper seizure list duly signed by the witnesses. It was reasonably believed that the above noted drivers of the vehicles obtained the cattle's either by stolen or fraudulent means as there was no any documents in support of the same nor could they indicate the source of its procurement. Then I deposited all the Buffalos and calf to the Khoar situated at Amaidighi, Fulbari. Whole process of search and seizure made between 05.30 hrs to 06.15 hrs.

Under the above fact & circumstances I therefore request you to start a case under proper section of law against the above noted drivers namely (i) Mahabul Alam (32 yrs) s/o Abdul Rasid of vill. Chocha, PS. Baishi, Dist. Purnea (Bihar) (ii) Md Sayed (29 yrs) s/o Farjun Ali of vill. Bhagaban pur, PS. Dalkhola, Dist. Uttar Dinajpur and arrange for the investigation.
