In producing herewith four (04) arrested accused persons  
Roy (M/23 yrs) S/O- Nimai Roy of Kawakhali, PO- Sushrutanagar, PS- Matigara,  
Dist- Darjeeling 2) Rohit Singha (M/22 yrs) S/O- Thiren Singha of Thiknikata, PO-  
Sushrutanagar, PS- Matigara, Dist- Darjeeling 3) Pradip Roy (M/35yrs) S/O- Faringa  
Roy of Choto Potu, PO- Ranidanga, PS- Phansidewa, Dist- Darjeeling 4) Anwar  
Hossain @ Saddam (M/29 yrs) S/O- late Amadh Hossain of Srirampally, PO- Settelite  
Township, PS- NJP, Dist- Jalpaiguri arrested u/s- 35 of B.N.S.S along with following  
seized articles viz:

- (1) One Iron made 5 inches hammer (house breaking implement) fitted with bamboo measuring about 20 inches in length from the possession of Nirmal Roy which was kept on his left hand.
- (2) One SABAL (iron made house breaking implement) measuring about 03 feet in length from the possession of Pradip Roy which was kept on his right hand.
- (3) One Torch Light from the possession of Anwar Hossain @ Saddam.
- (4) One empty bottle of 60 UP Himalayan Gold liquor.

I, ASI Krishnendu Roy of NBMC OP under Matigara P.S, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others to the effect that on 20.08.24 at 01.15 hrs received a source information that 10/12 youths have assembled at Kawakhali Gaisal Mandir Shamsan Ghat under Matigara PS with a view to commit dacoity at Kawakhali area. The fact was diarized in GDE vide NBMC OP GDE No- 704 dated 20.08.24. Subsequently, after sharing the information with my superiors and as per their direction, I along with PSI Abhijit Das, ASI Sk. Sabrati along with K-34 RT mobile van officer ASI Amal Roy and force C/1085 Mithun Debnath, C/340 Pranab Adhikary left for the place to work out the information with Govt vehicle bearing registration no WB 74 Q 8035. On way we called two disinterested persons namely Mithun Singha(39) S/O- Lt. Baldev Singha of Kawakhali, PO- Sushrutanagar, PS- Matigara, Dist- Darjeeling and Santosh Barman (36) S/O-Tarani Barman of Rupsingote, P.S- Bagdogra, Dist- Darjeeling and to whom we disclosed our identity and asked them to accompany us if any search and seizure is necessary for the purpose.

At about 02.35 hrs after reaching at Kawakhali Gaisal Mandir Shamsan Ghat under Matigara PS, I met my source and as pointed by the source we started approaching towards the spot and cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence. But, seeing the police party approaching towards them they tried to flee away from the spot. On hot chase we managed to apprehend four accused persons along with seized articles from their possession as mentioned above who disclosed their name & address as 1) Nirmal Roy (M/23 yrs) S/O-

However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there and were planning to commit robbery at Kawakhali area. They also stated that other persons namely Shiba Das, Kam Majumdar and other persons also with them who managed to flee away from there.

I thereafter, seized the above noted weapons in torch light under proper seizure in presence of witnesses and being acknowledged by the accused persons. The whole process of search, seizure & arrest was made in between 12:30 hrs to 01:30 hrs with videography on 20.08.24. Thereafter, I effected the above noted accused persons u/a 36 BNSA under proper memo of arrests duly signed by the accused persons.

Hence, a specific case may rightly be started under proper provision of law against the above noted accused persons namely- 1) Nimai Roy (M/22 yrs) S/O- Thiren Singha of Tinkrikata, PO: Sushrutanagar, PS: Matigara, Dist: Darjeeling, PIN: 728101, West Bengal, India. (M/29 yrs) S/O- Parman Roy of Chandi Bari, PO: Ranidanga, PS: Phansidewa, Dist: Darjeeling, PIN: 728101, West Bengal, India. (M/29 yrs) S/O- late Amadh Hossain of Sirampally, PO: Sankha Township, PS: NJP, Dist: Jalpaiguri and others and arrange for its investigation.
