Just on date 18/08/2024 at approx 9.45 PM I was sitting
at our Restaurant counter of Sagar Restaurant, M.R. Road, Khepau.
We were also with our customer along with Ladies & children were
leaving our premises after consuming the food were affected by
some unknown miscreants who were fully drunk & misbehaving
with Ladies & children we intervened the matter to resolve the
issue but the miscreant who were in numbers charged with bats &
bottles (kecks) on me & my staff members. We went here & there
to save us & they also threatened to bring more miscreants to
chase us with the number 400 to 500. Seeing this the customers
who were present then protested about the matter & call for help
to local police station. Later on we came to know names of few
persons. Anon Sharma, Bishu Das, Choh & Manish, Somu & Ansh
who were involved in the matter along with 10-15 miscreants
They also called on Restaurant premises with 10-15 persons to threaten us.
So I therefore request you to take legal action against
all the miscreants involved along with the persons mentioned
above & book the culprits under the law
