Sir,

In producing herewith 18 (Eighteen) pcs pitch board cartoon each containing 20 (Twenty) boxes having 50 (Fifty) pcs of Lighter (marked as Made in China) totalling 18000 (Eighteen thousand) pcs of Lighter (Marked as Made in China). I beg to state that on today i.e. 19.08.2024 at about 14:55 hrs I received a source information that one person kept some stolen lighter in his garage. Hence I diarized the matter vide EB, SPC GDE No. 104 Dt. 19.08.24 and informed the matter to ACP EB, SPC and as per his instruction myself along with Inspector Samrat Mitra, ASI Arghya Das, Ct 924 Avijit Kar all of EB, SPC left EB Office to proceed to Sarashi Kunj apartment, BDC Road, Hakimpara, Ward No. 16, PS- Siliguri, SPC to execute the information. This refers EB, SPC GDE No. 105 Dt. 19.08.24 and C.C. No. 53/24 Dt. 19.08.24.

At about 15:55 hrs we reached at Sarashi Kunj apartment, BDC Road, Hakimpara, Ward No. 16, PS- Siliguri, SPC and as per shown by my source, we entered into the Sarashi Kunj apartment, BDC Road, Hakimpara, Ward No. 16, PS- Siliguri, SPC and found that 18 (Eighteen) pcs pitch board cartoon had been kept in that place. Then one Sanjeev Kr Mani said that he is the owner of the articles. On demanded said Sanjeev Kr Mani could not produce any documents in support of above noted articles. Accordingly said Sanjeev Kr Mani kept the huge property in his custody as stolen, which is combustible and endanger for human life.

Then no other alternative I seized 18 (Eighteen) pcs pitch board cartoon each containing 20 (Twenty) boxes having 50 (Fifty) pcs of China Lighter (made in China) total 18000 (Eighteen thousand) pcs of Lighter (Marked as Made in China) from 16:35 hrs to 17:25 hrs with proper seizure list in presence of local witnesses under audio-video recording.

In this fact and circumstances I pray before you that kindly lodged a specific case against Sanjeev Kr Mani as per law to keep 18000 (Eighteen thousand) pcs of Lighter (marked as Made in China).
