Sir,

I Smt. Laxmi Ghosh, daughter of Late Lahiri Ghosh, resident of Sukumar Roy Road, Subhaspally, within S.M.C. Ward no.: XX(10), P.O.: & P.S.: Siliguri, District: Darjeeling do hereby Lodge this F.I.R. on the following effects:

1. That I am a divorcee. Four years back I meet with one person, named by Bidhan Paul, son of Biren Paul, resident of A.P.C. Sarani, Hyderpara, P.S.: Bhaktinagar, District: Jalpaiguri. The said Bidhan Paul promised me to marry me after getting divorce from his wife because his wife was not mentally fit. Subsequently the said Bidhan Paul provoked me for sexual relationship and thereafter we sexually intimated though I was not prepare for the same before marriage.
2. That later on I realised that the said Bidhan Paul is not ready to divorce his wife, as and when I came to know this fact, I retracted form the said relationship and since that day to up till now the said Bidhan Paul harrows me physically & mentally and the said Bidhan Paul also blackmailing me by saying that if I would not continue the sexual relationship with him, he would viral our relationship in internet.

That I met with one person, named by Anupam Sarkar, son of Late Adhir Sarkar of Malda, at present resides at Subhaspally, P.O.: & P.S.: Siliguri, District: Darjeeling with whom I shall be married very soon. But getting this information, the said Bidhan Paul severally abused me. Not only that the said Bidhan Paul defamed me in front of the said Anupam Sarkar by sending the text message so that the said Anupam Sarkar will retreat from the marriage.
4. That today the said Bidhan Paul came to my shop and in front of my neighbor, the said Bidhan Paul threatens me by saying that he will kill me & he will commit suicide if I shall marry the said Anupam Sarkar.
5. That after that incident, I was in mental trauma and for that reason there was delay in lodging this F.I.R.

So, therefore I request you to take appropriate legal action against the said Bidhan Paul.
