Said amount is duly transferred to the online fraudster on his bank account through his UPI - Mobile Number (UPI ID - Online4856online1@okcici UPI ID - Sanjeerk4979-1@OKCICI) for loan offer 1.5. The fraudster person at himself as a bajaj executive name - piryam she called me on 12/8/24 from his mobile number - 8981325199 and asked me to send him my id cards and bank Cancelled cheques. Myself forwarded this documents then he - demanded Rs - 3,500/- as processing fees and after demanding Rs - 13,660/- incase any person in such manner I send him total Amount of Rs - 1,02,258/- On 12/8/24 later I reached at bajaj finance office Savak road - Siliguri and it was clear to me that I have been cheated by the fraudster's name as piryam she

therefore I earnestly requested you to take necessary legal action against the culprit/fraudster for such cheating, misappropriation which breach of trust and Oblige.
