The humble Complaint of the above named Complainant

Most Respectfully States: -

- 1) That the Complainant is peace loving and law abiding citizen of India and residing at the above noted address with unblemished record.
- 2) That in the first part of the month of September, 2020 the complainant acquainted with the accused person and in relation to that the accused person came to the house of the complainant and approached her to purchase a big chunk of land and the accused person executed a registered power of attorney with transferable right and also received Rs. 1,00,000/- (Rupees one lac) in cash from the complainant's house and executed Angikar Patra (Money receipt). Subsequently the complainant found that the power of attorney executed and registered by the accused person is void as because the accused person had no title of the subject land in the power of attorney and the accused person in a fraudulent manner induced the complainant to deliver Rs. 1,00,000/- to the accused person and thereby deceived the complainant.

- 3) That the Complainant informed the matter to the I/C, NJP Police Station on 20/07/2024 through registered post being No. RW937476866IN which is duly received on 22/07/2024 and before the Commissionerate of Police, Siliguri on 20/07/2024 through registered post being No. RW937476999IN which is duly received on 22/07/2024, but till now no action has been taken.
- 4) That the Complainant is thus compelled to file the present Complaint before the I.d. Court.
- 5) That the Petition is bonafide.

In the above premises it is prayed that Your Honour would be kind enough to pass an order directing the I/C, NJP Police Station to investigate the matter and start a case on the basis of the complaint.
