**Subject:** FIR against unknown persons for damaging Govt. properties

Sir,

Today i.e. on 22/8/24 at around 2PM a gathering happened at the Office premises of the Siliguri Mahakuma Parishad. They reportedly came in c/w a deputation before the Chief Medical Officer of Health, Darjeeling. The Chief Medical Officer of Health, Darjeeling has an office set up in the same building of the Siliguri Mahakuma Parishad. The police force was also present at the premises in c/w the reported deputation.

However the agitators gathered at the premises, inter alia, damaged the glasses of the entrance of this building situated at the ground floor despite resistance from the police force. The picture of same is also enclosed. This is to add that this office has CCTV coverage, too which may kindly be explored.

Hence, I, Sri Nirmalya Gharami, WBCS(Exe), Addl. Executive Officer, Siliguri Mahakuma Parishad want to lodge this as an FIR and request you to take necessary steps accordingly.
