Respected Sir,

I, **Poushali Das**, daughter of Sukumar Das, wife of Rohit Singh, aged 22 years, residing at Chandal Jote, Simultala, near Ram Thakur Mandir, P.O. and P.S. Bagdogra, Dist. - Darjeeling, Pin - 734014, West Bengal wish to lodge a formal complaint against my husband, **Rohit Singh, (8849023517)** Son of Avdhesh Singh, previously resided at Bhutta Bari, Boro Shiv Mandir, Upper Bagdogra, P.S. Bagdogra, District Darjeeling; permanent resident of Rampur, Barhamdas, Khoksa Buzurg, District Vaishali, Pin - 844504, Bihar, his brother-in-law **Rohit Gupta (9614293734)**, father **Avdhesh Singh**, and mother **Deemanti Devi** Due to the continuous mental and physical violence, harassment and threats I have faced.

1. That Our marriage was solemnized on 26/01/2021 as per Hindu rites and customs at Bateshwar Nath Mandir, District Vaishali, Bihar. After marriage, we started our conjugal life at my matrimonial house located at Rampur, Barhamdas, Khoksa Buzurg, District Vaishali, Pin - 844504, Bihar. From this wedlock, a male child named Ivaan Singh was born on 26/01/2023.
2. That My husband works as a welding laborer for Reliance Company, which required him to move to various cities across India. Consequently, we shifted to his house at Bhutta Bari, Boro Shiv Mandir, Upper Bagdogra, P.S. Bagdogra, District Darjeeling, West Bengal. Currently, my husband is working in Gujarat, so he has arranged for my child and me to stay in Rampur, Barhamdas, in the Vaishali district of Bihar.
3. That Since our marriage, my husband has been subjecting me to continuous mental and physical cruelty. On many occasions, his cruel behavior extended to our child as well. Neighbors have had to intervene multiple times to prevent further harm. He frequently complained that my parents did not provide any dowry or articles at the time of marriage and that all the expenses were borne by him. He often belittled my parents' financial capabilities and their inability to fulfill his unreasonable demands.
4. That My husband has repeatedly insulted my modesty through abusive language and behavior for trivial issues that he fabricated. His actions are aimed at causing emotional and psychological harm to me and my minor child.

5. That My husband and his parents constantly distrusted me, especially whenever I spoke to anyone over the phone, including my parents. He would baselessly suspect me of infidelity. It is important to mention that, on numerous occasions, he forcibly restrained me, kept me confined, severed all communication with my parents, and threatened me with severe consequences without any reason.
6. That On August 22, 2024, his father **Avdhesh Singh** i.e. (my father-in-law), and **mother Deemanti Devi** i.e. (my mother-in-law) who is the second wife of Avdhesh Singh, provoked a situation based on unfounded suspicions and scolded me, ultimately telling me and my child to leave their house.
7. That After the heated argument over baseless accusations, they forcibly ousted me and my minor child from the house. Since then, we have been living with my parents, completely dependent on their support and kindness, as we have no place of our own to stay.”
8. That Around 23/08/2024, and again on 24/08/2024, his **brother-in-law Rohit Gupta**, called my mother from his phone number **9614293734** to her phone number **7679977195**, threatening and abusing her. He demanded that I be handed over to them; otherwise, they would abduct me and teach us a lesson using their influential powers.

Under the above circumstances, I am living in constant fear for my safety and the safety of my child. I request you to kindly register my FIR and take appropriate legal action against my husband Rohit Singh, his brother-in-law, Rohit Gupta, my father-in-law Avdhesh Singh, and my mother-in-law, Deemanti Devi
