**REF: A FOUR WHEELER MAHINDRA BOLERO B6 (O) BS-VI BEING REGISTRATION NO. WB 74 BH 0333.**

**SUB: Criminal breach of trust, cheating and dishonest misappropriation of the above referred vehicle by one Mr. Govinda Kumar, Son of Late Sohrai Ram, Resident of Mani Rohtas, Tehsil: Bikramganj, District: Rohtas, In the State of Bihar, PIN: 802212.**

I, Sri Pradip Kumar Roy, Son of Late Jagat Chandra Roy, Resident of 25 Satyajit Roy Sarani, Haiderpara, Ward No. 39 of Siliguri Municipal Corporation, Police Station- Bhakti Nagar, District- Jalpaiguri, PIN- 734006, in the State of West Bengal, would like to state you as follows:

1. That above referred Mr. Govinda Kumar had been working as a Senior Field Assistant in the Department of Special Bureau under the Government of India and in the year of 2017 he has been posted in the Siliguri Branch of the said department.
2. That in the year of 2020 I was also posted in the same branch at Siliguri as Assistant Field Officer in the Department of Special Bureau under the Government of India.
3. That he has thereby developed a good and friendly relationship with each other and I have had huge trust on him.
4. That I am/was the owner of the Bolero vehicle of Power-Plus ZLX model being its Registration No. WB 74 AZ 1467 which I have purchased in the year of 2019.
5. That being close friends, said Govinda Kumar has borrowed the said Bolero vehicle from me on several occasions for the purpose of his personal use.
6. That on 25.05.2021 also he has borrowed the said Bolero Vehicle from me for the purpose of going to his own house at Mani Rohtas, Tehsil- Bikramganj, District- Rohtas, in the State of Bihar and on the same

~~date~~ he has caused an accident with my said vehicle at Bahadurganchh under the jurisdiction of the then Kochadhaman Police Station, District- Kishanganj, in the State of Bihar.

7. That thereafter the Kochadhaman Police Station has taken custody of the said Bolero vehicle being Registration No. WB 74 AZ 1467 Vide Kochadhaman Police Station G.D.E. No. 582/2021 dated 25.05.2021.
8. That thereafter on 18.06.2021 I have released the said Bolero vehicle on personal bond from the Kochadhaman Police Station in a severely damaged condition.
9. That thereafter I have demanded damages to compensate the damage caused by him to the said Bolero vehicle being Registration No. WB 74 AZ 1467.
10. That thereafter I have expressed a wish to buy a new Mahindra Bolero Vehicle.
11. That thereafter it is stipulated by and between both of us that I shall purchase a new Mahindra Bolero B6 (O) BS-VI by paying a down payment of Rs.5,61,793/- (Rupees Five Lakhs Sixty One Thousand Seven Hundred Ninety Three) only and he shall pay the rest of the amount fixed for purchasing the said vehicle through EMI including the interest accruing thereof as compensation for the damage caused by him to my Bolero vehicle being Registration No. WB 74 AZ 1467.
12. That accordingly I have purchased a new Mahindra Bolero B6 (O) BS-VI being Registration No. WB 74 BH 0333 after payment of a sum of Rs.5,61,793/- (Rupees Five Lakhs Sixty One Thousand Seven Hundred Ninety Three) only in total as a down payment for purchasing a new Bolero vehicle.
13. That the said amount of Rs.5,61,793/- (Rupees Five Lakhs Sixty One Thousand Seven Hundred Ninety Three) only was paid by me in four transactions, as a down payment for purchasing the said vehicle, i.e. Firstly, a sum of Rs. 60,000/- (Rupees Sixty Thousand) only paid on 31.07.2021 Vide Money Receipt Memo No. SWPL/MMV/1216, Secondly, a sum of Rs. 3,50,000/- (Rupees Three Lakhs Fifty Thousand) only through Cheque Vide Cheque No. 631939 drawn on State Bank of India dated. 27.09.2021, Thirdly, a sum of Rs. 60,000/- (Rupees Sixty Thousand) only paid on 01.10.2021 Vide Money Receipt

Memo No. SWPL/MMV/2064 and Lastly, a sum of Rs. 91,793/- (Rupees Ninety One Thousand Seven Hundred Ninety Three) only paid on 04.10.2021 Vide Money Receipt Memo No. SWPL/MMV/2086.

14. That for the purpose of convenience or in other words, so that I don't face any unnecessary hardship/difficulty in case of non-payment of EMI by him as compensation for the damage I have accepted his proposal to register the said vehicle being Registration No. WB 74 BH 0333 in his name.
15. That it was stipulated by and between both of us that as soon as all the instalments of the said vehicle being Registration No. WB 74 BH 0333 are cleared by him, he shall forthwith transfer the registration in my name.
16. That since the purchase of the said vehicle being Registration No. WB 74 BH 0333 I have been using /possessing/ enjoying/occupying the said vehicle without any objection/obstruction from any corner.
17. That it is pertinent to mention here that he used to ask me to borrow my said vehicle being Registration No. WB 74 BH 0333 once in every year for a period of 12-15 days for the purpose of going to his own house at Mani Rohtas, Tehsil- Bikramganj, District- Rohtas, in the State of Bihar and I being his good friend permitted him on every occasion to take the said vehicle.
18. That recently on 13.06.2024 he has asked me to take/use the said vehicle being Registration No. WB 74 BH 0333 for a period of 12-15 days for the purpose of going to his house at Mani Rohtas, Tehsil- Bikramganj, District- Rohtas, in the State of Bihar and this time also I have allowed him to take the said vehicle.
19. That I was shocked while I received a 'violation notice' on 20.06.2024 in my registered mobile number being No. +919933003668 from the Sikkim Traffic which implies that he has taken my said vehicle being Registration No. WB 74 BH 0333 to Sikkim without my permission.
20. That on asking the reason behind taking the said vehicle being Registration No. WB 74 BH 0333 to Sikkim without my permission, he has not given proper response to such query.
21. That I am also surprised to notice that he has taken the said vehicle being Registration No. WB 74 BH 0333 for more than the period

permitted by me and even on repeated calls he is not returning the same which is causing enormous trouble/ inconvenience to me.

22. That for few days I am/was surprisingly noticing that he is not even responding to my repeated phone calls.
23. That thereafter on 08.08.2024 I have sent him a legal notice through my appointed Lawyer stating all the facts mentioned hereinabove and asking him to return the said Vehicle being Registration No. WB 74 BH 0333 or to respond/reply within a period of seven days from the date of receipt of the said legal notice.
24. That even after the lapse of seven days from the date of receipt of the said notice he has not responded to nor has he returned the said vehicle. And hence I have no other option left but to knock your door.

Under the above circumstances, I am requesting you to investigate the matter and take such legal actions against Said Govinda Kumar as may be necessary for the ends of justice.
