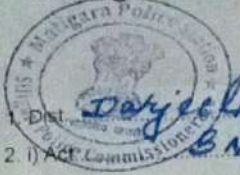

I Raksha Kumari Roy, d/o Subodh Kumar Roy, resident of Khali Bakari, P.S. Matigara District Darjeeling would like to Lodge this written Complaint on the fact in our Neighbourhood there is a family just adjacent to our house. That family members of that family used to abuse us with filthy language without any issue. There is a person named Pappu Roy, s/o unknown he used to start quarrel with our family every day and insult my mother with very bad language. Their son Pawan Roy is a dangerous person and I noticed that once last few months he is following me with heap friends wherever I go to school and tutions. He and his friend always passed bad, sensitive slang language towards me and my elder sister. Several time we made our protest regarding his bad activities and misdeed but he did not change his behaviour.

To day on 24/08/2024 at about 9.30 am when I was returning from my tution said Pawan Roy started to following me and made some bad, along towards against me. Then and there I raised my objection against his act but he became furious and threaten me that he will take orange

against me. I came to my home and reported everything to my parents. ~~Some~~ previously my parents who are very simple and general person, reported their issue to our panchayat and today they also reported the matter when they came back then at about 10.30 am said Pappu Roy and his son Pawan Roy come to our house and assaulted my father with Lathi and blows. My father got injury at his head, face then, I and my sister went to rescue him. Then said persons jointly attacked us and intentionally assaulted us with kicks and blows. Then after I some how rescued my family and tried to went to hospital for our treatment. then, one Milan Roy who Pappu Roy, Bina Roy and his sister Laxmi Roy, do Bacchan Roy. again entered into our premises and again assaulted my father and my Mother. Then Pawan Roy with one brick with intention to kill my father assaulted him with one brick at the head to my father and then fled away. Then and there he was taken to Hospital and he is now under treatment.

I am therefore praying that please take appropriate legal steps against. (1) Pappu Roy, (2) Pawan Roy, (3) Milan Roy
