S. BIKRAM SARKAR, son of Sri. Natu Sarker, permanent resident of Vill. Kawakhali, Medical More, P.O. Sushoutanagar P.S. Matigara, Dist. Darjeeling, would like to inform you that I am an electrician cum electronic appliances mechanic. Eight (8) months ago one ~~RITESH~~ RITESH THAPA, son of "Unknown", permanent resident of Vill. Kalamjote, P.O. Sushoutanagar, P.S. Matigara, Dist. Darjeeling came to my house along with one inoperative table fan for repairing. I asked him to pay Rs. 200 as a repairing charge. After repairing, I handed over his table fan, but he did not pay me my repairing fee, in fact he told me that he will pay after a few days but in vain.

On 23.08.2024, said RITESH THAPA again visited my house along with his above mentioned inoperative table fan asking me to repair it again. I refused him, and asked him to first pay my outstanding repairing charge, but he forcefully handed his fan to me and left the house. On 24.08.24, about 2:00 pm when I went to his house at Vill. Kalamjote, P.O. Sushoutanagar, P.S. Matigara, Dist. Darjeeling to hand over his fan to him after repair, he became furious and started to abuse me with filthy language, and assaulted me with my own helmet and bamboo. One BHASKAR SINGHA, son of Sri. Soni Kart Singh, who is his neighbour also assaulted.

in bamboo in order to kill me & anyhow fled
away from that place by hiring a TOTO. I was
severely bleeding from all over my body, received
veral injuries on my person and am now under
treatment. While fleeing, said RITESH THAPA and
ASKAR SINGHA threatened to kill me if they ever find
me in Kalamjote.


Therefore, request you to kindly take necessary
legal steps against RITESH THAPA and BHASKAR SINGHA
