Subject: Lodging an FIR.

Respected Sir,

This is to inform you that I am Mr Rabi Sankar Singh, S/O Chandrika Prasad Singh residential addressed at 4th Railway lane, Lokenath Nagar, Lower Bagdogra, Dist Darjeeling, West Bengal (734014), aged 31 years, by faith Hindu.

I would like to register an FIR against Subham Mahato, S/O Smt. Rana Mahato (Mother) residential address at Rajib Nagar, Darjeeling More (Mobile no: 8695093021) and two other unknown men (his friends). This incident took place at City Center Matigara premises at around 1:25am on Dt: 26.08.2024.

We went to Beer Republic at around 10:30PM. Then two of my friends (Akash Ram & Kushal Thapa) left Beer Republic at around 1:05am (Dt:26.08.2024). Then I paid the bill and left Beer Republic at around 1:12AM (Dt:26.08.2024) with my friend Abhishek Shakhari.

As soon as I took my vehicle (TVS N-Torq with vehicle no WB 74 BE 0727) from the parking and started moving towards the main road at around 1:25AM (Dt:26.08.2024), all of a sudden Subham Mahato and two of his friends stopped me forcefully. Then they started hitting me with iron knuckles & other pointed weapons aggressively. I was unable to defend myself against this sudden attack. They also snatched my wallet which contained INR.10,000 almost. They were continuously hitting me with pointed weapons, punches and kicks all over my body, especially my face & head. My left eye lid started bleeding and I fell down unconsciously.

My friends started chasing them when they saw that I was being attacked. Subham Mahato and his friends fled the site towards Chandmoni Rail Gate near Beumond.

When I regained my consciousness, I was in my friend's house (Akash Ram). Then I went to my home at around 9:30AM (Dt:26.08.2024) and took rest.

Considering the above-mentioned life-threatening attack on me, I would humbly request you to lodge an FIR against Subham Mahato and his friends (names unknown).
