Subject: Complaint for stalking, sexual harassment, homophobic attack and attempt to rape

Respected Authority,

This is to bring to your knowledge that Siliguri has become an open ground for criminals and lives of women and LGBTQ+ community is at stake. In the recent past there have been several incidents of homophobic/transphobic attacks on many members of the community. It is getting harder for the community people in Siliguri to live their life in peace due to extreme unsafe conditions, to travel in the street safely. I come before you with one such horrific incident that had happened yesterday.

1. Yesterday i.e. 22nd August, 2024 at around 10:30pm while returning from R.G.Kar incident protest rally Vivek Ghosh aged 24 years old and Meghna Kar aged 20 years old both residents of Siliguri was returning home in a toto. Both are NGO workers and are members of Siliguri Pride Walk.
2. Suddenly in Hakim Para, near Shanti more a person with a scotty in complete intoxicated condition start following them, he stalks them for straight 10 mins catcalling, threatening, and hurling abusive language at them. The scotty was a TVS JUPITER CLASSIC with the number plate WB74BQ 2988.
3. The said person keeps following them and eventually collides with the toto and gets down from his vehicle and violently charges at them, the person abused Vivek by calling him "hijra", "chakka", "khankir chele", he threatened Meghna and Vivek by saying "toder rape kore mere debo".
4. Vivek and Meghna were traumatised as they got down from the toto and the toto driver had left the place. The said person started attacking and recording them and falsely alleged that "ae hijra amake I love you bolche", "amar theke 10,000 taka chaiche", "era drugs korche".
5. After this episode he attacked Meghna and Vivek and assaulted both of them, he tried to hit Vivek's face and inappropriately touched Meghna's chest outraging her modesty.
6. The said person went to the extent of undressing himself, he opened his shirt, almost got half naked and started touching his own genitals and threatened that he would rape both of them. He further added that he would rape them and kill them.

There was a crowd of people but no one offered to help or protested against such a crime happening on the street. However, a person known to Vivek

- named Anandita saw the incident and took Vivek and Meghna from the place and hid them in a shop on the ground floor of her residential building.
8. Meanwhile, Vivek and Meghna were hidden the said person called 4-5 of his friends who were all drunk and carried weapons like knives, sticks, belts and wanted to attack them.
 9. They stood outside Anandita's building shouting, threatening, abusing and asking them to come out so that the person and his friends can assault them.
 10. The entire area's men were out and none of them helped the victims, Infact they were shaming the victim and talking nicely to the abusers. Since the said person belonged to that locality.
 11. Somehow, they were rescued from the incident and was taken to a safer space.
 12. Later this incident was reported to the Police by Meghna by dialling 100 who said this is not under their jurisdiction and suggested to call to Siliguri PS, on calling Siliguri PS, Saliash Rai (SI) said this does not fall under his jurisdiction, on showing rage to him he started talking and addressing it.

All the videos of the concerned person stalking, harassing, attempting to rape, death threats, undressing himself, sexually harassing, molesting, assaulting are attached with this letter of complaint. Kindly take cognizance to the same, lodge an FIR and press charges with appropriate Sections of the law and take speedy action against the person.

The question arises that given the current social conditions of Bengal, where rape, molestation and safety is at stake, what is Siliguri doing to keep their citizens safe from such evils of society? Why are people safeguarding such criminals in their locality? can Women and LGBTQ+ community people not live safely in Siliguri? Would request your cooperation and investigation to serve justice.
