With due respect, I SMT. SARITA ROY, Wife of Sri. Birendra Kumar Roy, Daughter of Late Dilip Das, presently residing at Jai Prakash Pandey Lane, P.S. Jogsar, Jagdishpur, Dist. Bhagalpur, Bihar-812002 beg to state that my father Sri. Dilip Das, S/o. Late Jamuna Das was the absolute owner and in possession of the land measuring about 0.0287 Acre along with a two storied building measuring 1700 sq.ft.(850 sq.ft. in each floor) standing thereon, comprised in R.S. Plot No. 2634, corresponding to L.R. Plot No. 5382, recorded in R.S. Khatian No. 2228, situated within Mouza Siliguri, J.L. No. 110(RS) 90(LR), Touzi No. 3(Ja), Pargana Baikunthapur, under Ward No. VIII of Siliguri Municipal Corporation, Khalpara, P.S. Siliguri, Dist. Darjeeling.

My father Dilip Das died intestate on 08/05/2014 leaving behind his two sons namely Ashish Das, Atish Das and four daughters namely Sarita Roy(myself), Dipa Devi, Sabita Devi and Punam Devi as his only legal heirs and successors and we have acquired right, title and interest in and over the aforesaid property jointly having 1/6th undivided share each.

Recently when I conducted search at the office of the ADSR Siliguri, I came to know that my brothers Sri. Ashish Das and Atish Das have already sold the entire joint property to SRI. RAJIB SAHANI, Son of Late Gorelal Sahani, presently residing at Dr. Kalinath Road, Khalpara, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling by executing a Deed of Sale being no.1-2478 for the year of 2022 registered in the office of the A.D.S.R. Siliguri, Dist. Darjeeling, and they have misappropriated the entire consideration amount and cheated me. On 24/06/2024, I have obtained a certified copy of such deed from of the A.D.S.R. Siliguri. From bare perusal of the said deed, I came to learn that my brothers Ashish Das and Atish Das have fraudulently and dishonestly represented that they are only surviving legal heirs of Late Dilip Das knowingly well that I along with my three sisters are also co-owners of the said property.

Therefore, I request you to investigate the matter and to take necessary legal action against my brothers Sri. Ashish Das and Atish Das, both are Sons of Late Dilip Das, resident of Dr. Kalinath Road, Khalpara, P.O. Siliguri Bazar, P.S. Siliguri, Dist. Darjeeling, Mobile No. 9064792486 and 98320 74828. And for this kindness, I shall much oblige to you.
