Respected Sir,

Sub: For non-payment of rented house of Rs. 7,000/- and water charge of Rs.200/- per month from May '24 – July '24 and till now by Bulan Ghosh (renter).

As per talk with Officer-in-Charge I like to draw your kind attention that Bulan Ghosh is availing my rented house on basis of Rs.7,000/- per month and water charge of Rs.200/- per month and electricity bill will be paid on every three months as per W.B.S.E.D.C.L. rule. Renter has paid only Rs. 5300/- towards Rs. 21600/- from May '24 – July '24. At present total dues is Rs. 16300/- that according to the aforesaid Tenancy Agreement has been expired on 30.06.24.

That since the month of May, 2024 renter is not paying rent and water charge.

That thereafter several times I have requested renter to vacate the tenanted premise, but renter has not vacated said tenanted premises.

That renter intentionally occupied the premises and creates problem to me.

That, I, am a senior citizen of India. At present my age is about 73 years and I am retired person of Nationalised bank and being harassed more than four months.

In this circumstances I have lost my mental peace, monetary, time, though I am bound to go to court for judgement it will take a very long time. So I request you to kindly take necessary steps to make vacate my premises at an early date in order to save my life.
