Sub: Written Complaint

Dear Sir,

With due respect, I Smt. Tanushree Karmakar, wife of Rajesh Dey Sarkar, resident of Bagdogra, P.S. - Bagdogra, Dist. - Darjeeling, beg to inform you that on 14.07.2024 my husband was brutally assaulted by one Parijit Ghosh @ Biru, son of Prasenjit Ghosh along with another 20 people near station more Bagdogra, a written complaint was given to the Bagdogra Police Station and the said police station has registered Bagdogra P.S. Case No. 246 of 2024, dated 15.07.2024 under section 140 (2)/117 (2)/109/3 (5) of BNS, accordingly investigation is going on regarding the brutal offence as mentioned in the above referred case, though any of the 21 accused persons could be arrested as all of them were absconding.

In between times the Ld. Sessions Judge at Darjeeling was kind enough to reject the anticipatory bail application of the accused persons, subsequently Hon'ble Division Bench of Circuit Bench at Jalpaiguri, of the Calcutta High Court, was kind enough to allow the anticipatory bail of three accused persons namely (1) Parakhit Ghosh @ Haru, son of Prasenjit Ghosh (2) Parijit Ghosh @ Biru, Son of Prasenjit Ghosh, (3) Manish Ghosh with a condition that they shall not enter Darjeeling District save and except for the purpose of attaining investigation and Court during the entire period of investigation and trial.

Since the day I lodged the written complaint I had been repeatedly suggested by many peoples to enter into compromise with the accused persons, it can be said in a way that I was being pressurized in an indirect way to withdraw my written complaint and settle the matter amicably, though I did not agree.

Today at about 4:00 p.m. in the afternoon I saw that the above noted three accused persons at Siliguri Court premises alongwith Prasenjit Ghosh, son of Prahlad Chandra Ghosh, Maloy Ghosh, Bhola Ghosh, Ratan Ghosh, Kaushik Deb, Pratap Ghosh, seeing me all these persons started abusing me saying "tui Kemon meye, amader jana acche, elakai aay, toke moja dekhachi", they also threatened me with dire consequences saying that I could not do anything to them and they got bail, hence they would see how to punish me in future, they also said that I shall face serious consequences once I enter Bagdogra area, when they tried to hamper my modesty by using filthy languages I strongly protested and subsequently resulted to a hitted argument and to my utter surprise all of them started physically assaulted me, in the process of such physical assault many of them have touched me in an inappropriate way, I can remember specially Kaushik Deb and Bhola Ghosh had put their hand upon my chest and pushed me and Prasenjit Ghosh pulled me by my hair, they

had caught hold of my "kurthi" and ripped my kurthi and Gold Mangalsutra was snatched away, by that time this incident was noticed by my colleagues who were present nearby and they have come to the spot and rescued me, while my colleagues were trying to rescue me, some of my colleagues were also physically assaulted by the above mentioned peoples.

The above narrated incident clearly indicates that, all the above noted persons have violated the condition of the anticipatory bail having no regard to the rule of law and they are very dangerous in nature.


