That after some years my husband began to build house in the year 2020 by taking loan from bank on land which is registered in my son's name, after completing house my sister in law's namely 1. Momoni ghosh@ Lipi wife of Prasenjit ghosh 2. Chumki mondal saha wife of Sri Subhankar saha 3. Soma mondal saha wife of Sri sayan saha all have started coming to my husband home day by day and started harassing me in different ways along with my mother-in law Smt.Purnima mondal ,when I complained to my husband and he kept my side and tried to convince them but they began to quarrel with him and physically assault him by all of them .my husband did not lodge any complaint to police station or any case in any court and tribunal due to reputation of family and maintain the relationship, but day by day their atrocities activities gone to increase, some times they used to say slang languages ,they torture me by making to cut the pipe of gas cylinder ,some time they shutdown the main switch of electricity and stop the stop cock of water supply whenever I want to say them about all the torture they began to physically assault me by different things. Some time my sister in law slap me, some time they use wooden stick to beat me. I told the all the incident to my husband and he protest them then they all together demand from me and my husband a sum of Rs.,3,00,000/, each others all of them they will vacate the house or else they will forcefully stay in the house and go on giving mental torture to me

Now I request before to you that please take necessary step, legal action against them from your ends.
