Subject:- F.I.R against **SAMIR SARKAR** S/o Nakul Sarkar of Adarpara, Ward No.11, Jalpaiguri, PIN – 735101, District Jalpaiguri for multiple theft of money.

Sir,

I, **Aditya Agarwal** S/o Sri Pradip Kumar Agarwal, resident of Agrasen Road, Siliguri, Post Office and Police Station:- Siliguri, in the district of Darjeeling would like to lodge a written complaint / F.I.R against the above named miscreants namely Samir Sarkar to the effects as follows:-

1. That I am the owner of Bharat Industries dealing in the business of rice packaging and selling, having my office at Village :- East Dhantala, Post :- Satellite Township, Police station:- Bhaktinagar, in the district of Jalpaiguri, Pin:- 734015.
2. That I have hired the above said miscreant in the 1<sup>st</sup> week of December 2022 to assist in day to day tasks such as depositing money in bank account of our firm and collecting payments from different purchasers etc.
3. That on 06.05.2023, I discovered that a sum of money amounting to Rs.7,40,000/- (Rupees Seven lakhs Forty Thousand only) was missing from the drawer of my office and upon my diligent efforts to trace out the money it was found that the above named miscreant namely Sri Samir Sarkar has stolen the money and said miscreant has confessed to have stolen the money and he further admitted his theft in writing and further upon his apology I did not take any legal action against the said miscreant as he promised to refund the money by partly taking the loan and partly getting the money deducted from his salary which is also subscribed in writing on Indian Non Judicial Stamp Paper of Rs.100. However, said miscreant failed to stand on his promise to repay the money and kept on taking time on different pretexts. And further he was continuing his job negligently and now he has even stopped coming to work.
4. Samir is flatly denying me that he wont refund our stolen money from my office to me and I dont dare to ask him for my money and also challenged me if i could take the money from him in any way out
5. That I humbly request your good self to take immediate step against the said miscreants who is very dangerous in nature and book the said culprits under appropriate provisions of law.
