Subject: Prayer for Lodge a complaint regarding theft in a Scrap Shop.

Respected Sir,

I, Shri Biman Sarkar S/O Late S. Sarkar resident of South Deshbandhu Para, Ward No – 30, Siliguri, Dist – Darjeeling would like to inform you that on 17/08/2024 around 21:27 hours some unknown miscreants had entered in my scrap shop namely M. B. B. S Traders located at adjacent of Asian Highway II, near Dabgram, 12<sup>th</sup> Battalion.

That Sir, on that night the unknown miscreants after taking entry into my shop, they have stolen away my scrap items like i) Spring parts, ii) Aluminum, iii) Wheel Ring, iv) Old Motor Parts, and some other valuable parts of vehicles which value will be around Rs. 30,000/-.

Sir, after few days i.e. on 23/08/2024 the same miscreants with a view to thief further entered my shop and made the criminal offense in my same shop and again they have stolen away my scrap items which value estimated amount approximately Rs. 40,000 /-.

That Sir, I have already been contacted with your police station verbally and your police staff have collected the CCTV footage which fitted surrounding my Scrap Shop (M. B. B. S Traders), and today I am submitting here, with written complaint before your good self and I fervently requested to your kind self that you may take a proper lawful legal actions against the culprits and this complaint letter may be treated as F. I. R and obliged.
