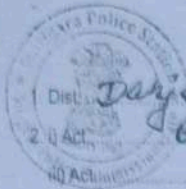

Sub : Complaint.

Respected Sir,

I, **SRI SHIBU MUNDA**, Son of Late Ashilal Munda, resident of Nischintapur Tea Estate, Post Office & Police Station Matigara, District Darjeeling, (W.B), Pin - 734010, the undersigned would like to bring to your kind notice and state as follows :-

1. That I along with one **SRI BABLU KACHHUA**, Son of Late Dhiren Kachhua, resident of Sukhani Basti, Post Office & Police Station Nagrakata, District Jalpaiguri, (W.B), Pin - 735225 are the owners of land measuring 0.41 Acres, as described in the schedule below, vide a registered Deed of Sale being Deed No. **7681** for the year **2023** and since the date of such purchase are in physical possession of the same having permanent, heritable and transferrable right, title interest therein. The said land has also been recorded in our names in L.R. Khatian No. **2885** and **2886**. I had also constructed a tin shed structure in and over my said land.
2. That recently few persons, being the local land grabbers are trying to encroach upon the said land claiming ownership over the said land and they have been disturbing my possession of the same.
3. That on 27.08.2024 in the morning some unknown miscreants had demolished the tin shed structure standing in and over my said land. Few persons were seen present at the spot and on being enquired, they stated that they were engaged by **Sri Pratap Kedia**, Son of K.C. Kedia, Resident of St. Micheal Road, Sevoke Road, Near Marwari Bhawan, Siliguri, Post office Sevoke Road, Police Station Bhaktinagar, District Jalpaiguri to restrain me from entering into my land.

4. That at such point of time the local people of the village came to the spot and clarified the actual state of affairs with respect to the below Schedule land and also the fact of my ownership in and over the said land and thereafter the said persons on being convinced left the spot.
5. That on further enquiry I could ascertain that the men and agents of said Pratap Kedia had demolished the tin shed structure. It could also be learnt that Sri Pratap Kedia have manufactured some false, forged and fabricated documents and have hatched up a conspiracy to grab my said land. They had also stolen the tin and other materials kept in the said land.
6. That a serious situation was created on 27.08.2024 and I could somehow retain possession of my said land with the aid and assistance of local people and restrain the said persons from dispossessing me and taking forcible possession of the below Schedule land.
7. That it is worth mentioning that the entire land adjoining the land as described in the Schedule below was owned and possessed by persons belonging to Tribal community and it could be presumed that the said Pratap kedia got some land recorded in his name by some foul play and with the collusion with few officials of the office of the B.L. & L.R.O, Matigara and the same is required to be investigated thoroughly and offenders be punished.
8. That I humbly submit that I belong to tribal community and have been passing days in tremendous hardship and financial crises and I am unable to resist the said persons as they are very rich and influential and have anti social elements at their disposal.
9. That the said persons have committed theft of my valuable property and have also attempted to take forcible possession of my property, being property belonging to person of Schedule Tribe Community.

10. That the said persons on basis of some false and forged documents are trying to take forcible possession of the same and I am apprehensive of my life and limb and also my property.

Under the above circumstances, it is humbly prayed that your goodself would be kind enough to enquire and investigate into the matter and take necessary action against the aforesaid person at the earliest.


