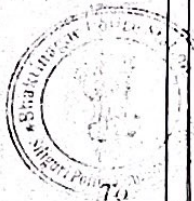

In producing herewith following four accused persons namely 1) Raju Oraun (M/48yrs) S/O- Lt Babul Oraun of Memglas TG, PO- Sali Hat, PS- Malbazar Dist- Jalpaiguri A/P- Upper Bhanu nagar, PS- Bhaktinagar, Dist- Jalpaiguri 2) Baizu Sahani (M/20yrs) S/O- Sande Sahani of Mallaguri, Ratan Lal Busty, W.No- 01, PS- Pradhan nagar, Dist- Darjeeling 3) Prabin Sahar (M/28yrs) S/O- Maherman Sahar of Chesopani, Khotang, PS- Chesopani, Dist- Khotang, Nepal A/P- Kamala nagar, PS- Bhaktinagar Dist- Jalpaiguri, 4) Gobind Paswan (M/24yrs) S/O- Lt Ram Setwak Paswan of Prakash nagar, Paswan Busty, PS- Bhaktinagar, Dist- Jalpaiguri with following seized articles viz:

- 1) One iron rod approx 24 inches recovered from the exclusive and conscious possession of Raju Oraun.
- 2) One iron made 'Hand Sikle' locally called as Hasuwa recovered from the exclusive and conscious possession of Baizu Sahani.
- 3) One iron rod approx 18 inches and Hacksaw blade recovered from the exclusive and conscious possession of Gobind Paswan.
- 4) One iron rod approx 20 inches recovered from the exclusive and conscious possession of Prabin Sahani.

I, SI Youct Lepcha S/O Jai Tshering Lepcha of Bhaktinagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted 1) Raju Oraun (M/48yrs) S/O- Lt Babul Oraun of Memglas TG, PO- Sali Hat, PS- Malbazar Dist- Jalpaiguri A/P- Upper Bhanu nagar, PS- Bhaktinagar, Dist- Jalpaiguri 2) Baizu Sahani (M/20yrs) S/O- Sande Sahani of Mallaguri, Ratan Lal Busty, W.No- 01, PS- Pradhan nagar, Dist- Darjeeling 3) Prabin Sahar (M/28yrs) S/O- Maherman Sahar of Chesopani, Khotang, PS- Chesopani, Dist- Khotang, Nepal A/P- Kamala nagar, PS- Bhaktinagar Dist- Jalpaiguri, 4) Gobind Paswan (M/24yrs) S/O- Lt Ram Setwak Paswan of Prakash nagar, Paswan Busty, PS- Bhaktinagar, Dist- Jalpaiguri and 5/6 others to the effect that on 30.08.2024 at 00:25 hrs received a specific source information that 9/10 miscreants have assembled at the River Side, Upper Bhanu nagar under Bhakti Nagar PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Bhakti Nagar PS and diarized the fact in General diary vide Bhakti Nagar PS GDE No 1447/24 dated 30.08.2024 and as per order I along with ASI Amardeep Chhetri, ASI Dipak Karmakar, C/374 Debraj Biswas all of Bhaktinagar PS, SPC, left for River Side, Upper Bhanu nagar under Bhakti Nagar PS, to work out the information in hand.

At about 00.45 hrs we arrived at River Side, Upper Bhanu nagar under Bhakti Nagar PS, as indicated by the source we noticed that 09/10 persons assembled at River Side, Upper Bhanu nagar under Bhakti Nagar PS, and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but the police party after some how managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 5/6 persons managed to fled away from the spot taking the advantage of darkness and open place.

On interrogation the apprehended accused persons disclosed their name and identity as noted above and also stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession.

On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.

Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the accused persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 30/08, 2024 in between 01.05 hrs and 01.35 hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely 1) Raju Oraon (M/48yrs) S/O- Lt Babul Oraon of Memglas TG, PO- Saili Hat, PS- Malbazar Dist- Jalpaiguri A/P- Upper Bhanu nagar, PS- Bhaktinagar, Dist- Jalpaiguri 2) Bazu Sahani (M/20yrs) S/O- Sande Sahani of Mallaguri, Ratan Lal Busty, W.No- 01, PS- Pradhan nagar Dist- Darjeeling 3) Prabin Sahar (M/28yrs) S/O- Maherman Sahar of Chesopani, Khotang, PS- Chesopani, Dist- Khotang, Nepal A/P- Kamala nagar, PS- Bhaktinagar Dist- Jalpaiguri, 4) Gopind Paswan (M/24yrs) S/O- Lt Ram Sewak Paswan of Prakash nagar, Paswan Busty, PS- Bhaktinagar, Dist- Jalpaiguri and others kindly arrange for its investigation
