

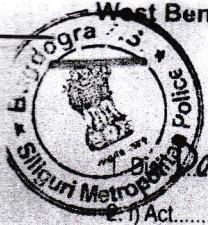

In producing herewith following accused persons namely (i) Dhiraj Roy @ Chiku, aged 25 yrs, s/o- Arpan Ch. Roy, resident of Gossainpur, Rupsingjote, (ii) Swapan Sutradhar @ Goda, aged 25 years, s/o- Gouranga Sutradhar, resident of Gossainpur, Rupsingjote, (iii) Krishna Minj, aged 24 yrs, s/o- Late Khasru Minj, resident of Moomi T.E, Bhistijote, (iv) Naren Barman, aged 24 yrs, s/o- Avinash Bamnan, resident of Gossainpur, Rupsingjote, (v) Prakash Tigga, aged 28 yrs, s/o- Kalu Tigga, resident of Moomi T.E, Bhistijote and (vi) MD Rahaman, aged 27 yrs, s/o- MD Nasim Akhtar, resident of Gossainpur, Rupsingjote, all are under PS- Bagdogra, Dist- Darjeeling (not verified) under custody along with following seized articles:

- (i) One white colour torch light from the possession of Dhiraj Roy @ Chiku, marked as Exhibit-A.
- (ii) One iron rod having length approx 26" from the possession of Dhiraj Roy @ Chiku, marked as Exhibit-B.
- (iii) One iron made knife having total length approx 8" including plastic butt measuring approx 2.5" from the possession of Swapan Sutradhar @ Goda, marked as Exhibit-C.
- (iv) One iron made hammer from the possession of Prakash Tigga, marked as Exhibit-D.
- (v) One iron made Hansua (da) measuring body length approx 9" and butt approx 6" (total 15") from the possession of Krishna Minj, marked as Exhibit-E.
- (vi) One iron made plass from the possession of Naren Barman, marked as Exhibit-F.
- (vii) One gray colour bag styled as "JMD TEXFAB PVT. LTD." from the possession of MD Rahaman, marked as Exhibit-G.
- (viii) One cotton made rope measuring length approx 6'8" from the possession of MD Rahaman, marked as Exhibit-H.

I, ASI Munna Ahmed of Bagdogra PS, SPC, do hereby lodge this written complaint against the above noted arrested six accused persons and 4/5 other unknown miscreants to the effect that today on 29.08.2024 at 00:45 hrs I received reliable source information that a group of miscreants have assembled near Jangli Baba more beside AH-2 under Bagdogra PS and they have been preparing to commit dacoity. Accordingly, I informed the matter to O/C Bagdogra PS and diarized the matter in GD vide GDE No. 1319 dated 29.08.2024 and as per his kind direction formed a raiding team consisting SI Debabrata Kundu, C/1509 Sourav Roy Sarkar, VP/01 Ansalam Kujur, VP/02 Pradip Roy, CV/386 Kishor Ranjan Hawladar leaded by me. Then at 00:55 hrs as per direction, we left for Jangli Baba more beside AH-2 under Bagdogra PS to work out the secret source information vide Jangli Baba more beside AH-2 under Bagdogra PS GDE No. 1320 dated 29.08.2024. On the MCC No. 224/24 dated 29.08.24. This refers to Bagdogra PS contacted with night mobile van officer SI Pradip Kr. Sarkar and informed him to come at Panighata more to accompany us. Night mobile van officer & force joined us at Panighata more. Then we proceeded for Jangli Baba more beside AH-2 under Bagdogra PS and at around 01:05 hrs we reached there and made an ambush there. We parked our Govt. vehicles away from the place. Being shown & indication by source we saw a group of about 10/12 persons there. We started to encircle them from all side. All on a sudden some of them noticed us and tried to flee away from the spot. But after hot chase we managed to apprehend six suspects there in red hand. Then we searched their persons. The process of searching started at 01:22 hrs. They were armed with deadly weapons and equipments to commit dacoity, house breaking etc. On search, we recovered one white colour torch light, one iron rod, one iron made knife, one iron made hammer, one iron made Hansua (da), one iron made plass, one gray colour bag and one cotton made rope from their joint possession. Accordingly, we interrogated them. On interrogation, they could not give any satisfactory answer regarding their presence at that place at the odd hours of night. On demand they failed to produce any valid document for carrying and possessing those deadly weapons and equipments. They gave different statement in different times. On interrogation, they revealed their identity as namely (i) Dhiraj Roy @ Chiku, aged
