Sir,

I, Sri Anil Kr. Ray, Son of Shyam Bahadur Ray, Resident of Chakarmari, Khoribari, P.O & P.S. Khoribari, Dist- Darjeeling would like to state you that my brother-in- law had lodged a GDE against Rohit Yadav, Son of Binod Yadav and his family members before Pradhan Nagar Police Station on 28.08.2024 at around 9:30 PM against torture faced my Niece Nitu Ray after her marriage by her husband and her in-laws. I along with my brother-in-law Niraj Ray and my family members went to matrimonial house of my niece situated at Pokhajote, near National Public School, Champasari, P.O. & P.S. Pradhan Nagar, Dist- Darjeeling at around 9:45 PM. When we reached there we called out Nitu Ray from outside the house and Sumit Yadav, Son of Binod Yadav came out of the house and he started abusing us with filthy languages and threatened us. Soon after that Amit Yadav, Son of Binod Yadav, Rohit Yadav, Son of Binod Yadav, Binod Yadav, Indu Devi, Wife of Binod Yadav and Viva Yadav @Guddia Yadav daughter of Binod Yadav and Chandan Yadav, s/o not known came out of the house and started threatening us that if we don't go back they will kill us and my niece. That in the meantime Sumit Yadav took out his mobile phone from his pocket and he called somebody and in no time 10 to 15 people namely Pradeep Saha, Ravi Bhagat, Avijit, Pradip Gupta along his friends came loaded with iron rode, Knife, lathi, nukkles, hockey stick came to the house and started hitting us brutally.

That Sumit Yadav, Rohit Yadav, Amit Yadav and Chandan Yadav came out of the house and accompanied them. They even tore off my sister's clothes in order disrobe her modesty and they also touched her upper part of the body in an inappropriate manner and pushed her so hard that she fell down to the road. That in the meantime I along with my family ran towards her in order to save her and as result I and my brother Sushil Ray sustained severe head injuries and my father also sustained several injuries in his body who is a 72 years old aged senior citizen and is in lot of pain and agony and presently admitted to Siliguri District Hospital.



That they also snatched my gold chain and also snatched money and gold chain of my brother. That they have threatened us that they will find us and kill the entire family members.

That they also mentioned that they have no fear of laws and are very powerful members of the society and no law and order can do anything to them. They have also threatened us that they will lodge a false FIR against us so that even police personnel won't be able to help us any further. That I would like to request you to kindly take necessary legal action against the above-mentioned persons in accordance to the law.
