Sir,

In producing herewith one arrested accused person namely Bishal Biswakarma (M-22yrs) s/o Late Dipak Biswakarma R/O Faktiamore, Khudiram Colony PS- Bhaktinagar, Dist- Jalpaiguri along with the following articles under proper seizure list: -

[1] 21 (Twenty one) sealed bottles of 70 UP PET India Made Liquor "KACHI" each bottle containing 300 ml, i.e. 300 X 21 = 6.300 ml, having M.R.P. of Rs. 40/- i.e 40 X 21 = 840/-, and marked as "Exhibit-A" out of which 01 (One) bottle taken as a sample and marked as "Exhibit -A-1".

I, ASI Prasenjit Barman s/o Lt. Sarat Chandra Barman of Ashighar OP under Bhaktinagar Police Station Siliguri Police Commissionerate would like to lodge this written complaint against the above-noted arrested accused person namely Bishal Biswakarma (M-22yrs) s/o Late Dipak Biswakarma R/O Faktia more, Khudiram Colony PS- Bhaktinagar, Dist- Jalpaiguri to the effect that today on 30/08/2024 at 19.10 hrs, I received a piece of source information that one person is selling liquor in his house at Faktia more, Khudiram Colony under PS – Bhaktinagar without any valid license. Accordingly, the fact is diarized in the General Diary vide Ashighar OP GDE No.1130 Dated 30/08/2024, and shared the information with O/C Ashighar OP and as per his kind direction, I along with force left for Faktia more, Khudiram Colony under PS – Bhaktinagar to verify the veracity of source information in hand. After reaching spot as identified by the source we held a raid at the house of accused Bishal Biswakarma and managed to apprehend him. On being asked he disclosed his identity as noted above and stated that he has stored the illicit liquor and is selling the same from his house without any valid license for his wrongful earn. On further search, the above-noted seized articles were recovered from his house. On-demand he failed to produce any valid license/papers for selling and storing such articles. On further interrogation, he stated that he had been involved in selling and storing illicit liquor without any valid license for the last few months for his illegal gain. Then, I seized and labeled the above-mentioned liquor under the proper seizure list and arrested the person mentioned above named Bishal Biswakarma after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.55 hrs to 20.17 hrs under proper videography and arrest the accused person u/s 35(3) BNSS 2023.

Under the above-noted fact and circumstances, I, therefore, pray before your good self that a specific case may kindly be initiated against the arrested accused person Bishal Biswakarma (M-22yrs) s/o Late Dipak Biswakarma R/O Faktiamore, Khudiram Colony PS- Bhaktinagar, Dist- Jalpaiguri under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
