Subject : Written Complaint Against Pradip Ghosh the Proprietor of "Gour Nitai Mistanna Bhandar"

Respected Sir,

On 14.08.2024 a message was received from Darjeeling Legal Service Authority regarding a raid to be conducted by Legal Consultant, Kolkata, Seva Kendra, Siliguri and Anugyalaya Darjeeling for rescuing children from "Gour Nitai Mistanna Bhandar" under Bagdogra PS. Accordingly, as per direction I PSI Adreesh Ray of Bagdogra PS, SPC along with force provided assistance to (i) Bidya Tamang, CPO Anugyalaya Darjeeling, (ii) Pradesh Gurung, CP Worker of Darjeeling (3) Alishya Yadav Project Co Ordinator Seva Kendra Siliguri, 4) Saptarshi Biswas, SPD International Justice Mission, Topsis, Kolkata, 5) Piyali Mukherjee Sarkar, Legal Consultant, Kolkata for rescue operation at "Gour Nitai Mistanna Bhandar" under Bagdogra PS and rescued 08 numbers of children from there. On being asked they stated that they are working there as labour without their will from last couple of days. The proprietor of said shop forcefully engaged those children for working in his shop. There after I produced those children before CWC, Siliguri and as per the kind direction of CWC I handed over those children to Jalpaiguri Korok Home on 14.08.24. On further enquiry it could be learnt that out of 08 children 03 are at the age limit of 14 years.

Hence, I pray to before your kind Honour that a specific may kindly be initiated against Pradip Ghosh the Proprietor of "Gour Nitai Mistanna Bhandar" as per proper section of law and obliged.
