Accordingly, I informed the matter to O/C Bagdogra PS and as per direction I along with ASI Amit Lama, ASI Munna Ahmed, VP/02 Pradip Roy, LHG/501 Anjali Biswas, CV/375 Jogesh Barman & CV/389 Janak Singh left for Katajhar, Taipoo T.E to work out the secret source information. This refers to Bagdogra PS GDE No. 1389 dated 30.08.2024. At around 11:45 hrs we reached at Katajhar, Taipoo T.E and had been waiting for the source indication. After a while, the source indicated the house of the suspect and we proceeded to hold raid at the said house and managed to apprehend one person there and interrogated him. On interrogation, he revealed his identity as Rajib Chettri @ Chhetri, aged 27 yrs, s/o- Pradip Chettri @ Chhetri, resident of Katajhar, Taipoo T.E, PS- Bagdogra, Dist- Darjeeling and he introduced himself as the owner of the house. Accordingly, I seized that liquor under proper seizure list and at last, arrested the accused Rajib Chettri @ Chhetri (as noted above) after observing all legal formalities and telling him the ground of arrest and issued memo of arrest in this regard. The process of search, seizure & arrest was made in between 12:06 hrs and 12:50 hrs on 30.08.2024. The entire process of search, seizure & arrest is done through audio-video electronic means using mobile phone and then the same audio-video record is converted to a pen drive using computer system.
