In producing herewith one accused person namely Krishna Roy (M/69 years) S/o Lt. Amiri Roy of Matangini Colony- 1, Tikiapara, ward no-28, P.S- Siliguri, Dist-Darjeeling along with the following seized articles as per proper seizure list:

1. 10( Ten) Pet bottles of HIMALAYAN GOLD 60 UP India made liquor each bottle containing 600 ML

With due respect and humble submission, I ASI Debasish Das S/O- Sri Haripada Das of Siliguri PS under Siliguri Police Commissionerate do hereby lodge this written complain after producing herewith the above-noted seized articles to the effect that on 30.08.24 at 18.25 hrs while performing PS mobile van duty received source information that one person namely Krishna Roy was selling liquor in his house situated at Tikiapara, Matangini Colony- 1 under Siliguri PS/SPC, for his wrongful gain without any documents/license. Diarized the fact in GD vide Siliguri PS GDE No- 1561, dated 30.08.24. As per your kind instruction myself along with PSI Koushik Raha, ASI Rabin Lama, ASI Subir Sen, C/160 Soumen Sarkar proceeded to the PO to work out the information. At about 20.15 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid at the house of the above noted accused person and able to detain one person, who disclosed his identity as noted above. On being searched the above-noted bottles of liquor recovered from his house. Further, being asked he confessed that he is doing the business of selling and storing liquor in his house since long for his wrongful gain without any valid documents/license. Then, in the presence of available witnesses, I seized the above-noted articles from the PO after prepared proper seizure list. (The seizure was made in between 20.25 hrs to 20.45 hrs) the process of search and seizure also audio-video graphed at the PO. As he has violated the rules and norms of Bengal Excise Act, I arrested the apprehended accused person namely Krishna Roy (M/69 years) S/o- Lt. Amiri Roy of Matangini Colony- 1, Tikiapara, ward no-28, P.S- Siliguri, Dist-Darjeeling after observing all sorts of formalities u/s 35(1) BNSS appraising him the ground of arrest.

I therefore request you a specific case may kindly be started against the accused person namely Krishna Roy (M/69 years) S/o- Lt. Amiri Roy of Matangini Colony- 1, Tikiapara ward no- 28, P.S- Siliguri, Dist-Darjeeling under proper section of law and arrange for investigation
