I, SI Ganesh Roy of New Jalpaiguri PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Gita Saibo (38), D/o- Udi Saibo of Kotiajote PS Naxalbari Dist. Darjeeling under arrest along with following seized articles;

1. Thirteen (13) nos of Plastic Jar in contents Local made Id Liquor locally called as "Cholai" ' each Plastic Jar 5 Ltrs (Total 65 Ltrs approx) , Marked as Exhibit-A from which 01 Ltr taken in one plastic bottles as sample for examination Marked as Exhibit-A1 .

I am submitting a written complaint against the above noted female accused person to the effect that today on 30.08.24 at 11-10 hrs received source information that one female person was carrying and selling Id. Liquor illegally at I.O.C. More under NJP PS illegally to its customers without any valid license and the local people very annoyed against the lady. Accordingly I informed the matter to you and duty officer of PS and as per direction Myself along with ASI Nilam Swarnakar , CV-297 Putul Roy , CV-306 Biswajit Roy, LC- 1328 Sangita Maley left from PS to verify the veracity of information. On arrival at the spot at 11-35 hrs it was found that one lady mentioned above was selling liquor illegally to her designated customers to earn huge money for her livelihood desperately at I.O.C. More , near NJP Rail station . On seeing the police party the customers as well as the seller tried to flee away, but the seller was apprehended by lady police. On being asked she disclosed her name and address mentioned above. Thereafter in presence of witnesses I recovered Thirteen (13) nos of Plastic Jar in contents Local made Id Liquor locally called as "Cholai" ' each Plastic Jar 5 Ltrs (Total 65 Ltrs approx) from the possession of the apprehended lady and seized the same as per proper seizure List and labeled duly signed by her and also witnesses. On being asked she failed to produce any valid document or license for selling the liquor and confessed her guilt. As such I arrested the above noted accused person u/s 35 BNSS with the help of lady force as It's a violation under Bengal Excise Act with strictly maintaining her modesty. This seizure & arrest was made in between 11-45 hrs and 12-15 hrs (seizure Total approx 65 Ltrs).

Therefore, I request you to start a specific case under the proper section of law against the arrested female person namely Gita Saibo (38), D/o- Udi Saibo of Kotiajote PS Naxalbari Dist. Darjeeling and arrange for its investigation.
