In producing herewith three (3) accused persons namely 1. Mithu Gowala (32) S/o Lt. Raju Gowala of Fatapukur , Jhanjhipara PS Rajganj Dist. Jalpaiguri 2. Akash Singh (35) S/o Lt. Sankar Singh of Gerabari PS Kodha Dist. Katihar, Bihar 3. Shibsankar Sikder (29) S/o Lt. Nripen Sikder of Purba Dhantala , Fulbari PS NJP Dist. Jalpaiguri along with seized articles viz

1. One iron made called as "Sabal" having length measuring approx 4 feet from the possession of accused Mithu Gowala
2. One iron made Sword having length measuring approx 3 feet including butt from the possession of accused Akash Singh.
3. One iron made "Hasua" one side sharp having length approx 2 feet including wooden butt from the possession of accused Shibsankar Sikder.
4. One Plastic ground sheet green and yellow colour.
5. Two Electronic torch light from the PO.
6. Two Flake Cigarette open packets in containing 15 pcs Cigarette from the PO.

I SI Tanmay Kundu of New Jalpaiguri PS, SPC do hereby lodge a written complaint against the above noted accused persons and others 6/7 persons to the effect that on 30.08.24 at 22-50 hrs received secret source of information to the effect that some miscreants armed with deadly weapons were assembled in a dark place at Kawakhali ground near Utsadhara under NJP PS with a view to commit dacoity, Accordingly without waste any time I informed the matter to you and duty officer of PS and as per your kind direction myself alongwith, AS Sudarshan Mandal, C/1462 Sajan Tamang, VP-13 Jamirul Islam CV-297 Putul Roy, CV-306 Biswajit Roy, CV-82 Niru Kumar Yadav left from PS vide noted in NJP PS GDE No. 1755 dt. 30.08.24 and called night mobile van officer ASI Pradip Sarkar and force for Kawakhali ground to verify the veracity of the information and to work upon it . We reached near the spot as confirmed by the source at about 23-05 hrs and stopped out vehicle at considerable distance from that place and we started walking towards the said place and we reached near the place and found a group of 9/10 persons were gossiping in a dark place at that place. We started approaching towards them slowly ambushing ourselves in the darkness. But unfortunately one of them see the police and try to flee away from there. Somehow, after a hot chase we able to apprehend the 03 (three) persons noted above and the others 6/7 persons managed to flee away from the spot. On interrogation they disclosed their identity which not verified and they also stated that they alongwith their other associates assembled there with a view to commit dacoity after making full preparation in the adjacent area of Porajhar under NJP PS. Thereafter all the apprehended persons were searched. During searching I found and recovered the above noted articles from the possession as well as Place of occurrence and seized the same as per proper seizure list duly sign by them and the process of search and seizure as been captured in videography as per provision of law in presence of witnesses. Accordingly I arrested the above noted accused persons u/s 35 BNSS. The all persons were arrested with proper memo of arrest. The seizure and arrest made in between 23-10 hrs to 23-40 hrs.

So I pray before you that a specific case may kindly be started against namely 1. Mithu Gowala (32) S/o Lt. Raju Gowala of Fatapukur , Jhanjhipara PS Rajganj Dist. Jalpaiguri 2. Akash Singh (35) S/o Lt. Sankar Singh of Gerabari PS Kodha Dist. Katihar, Bihar 3. Shibsankar Sikder (29) S/o Lt. Nripen Sikder of Purba Dhantala , Fulbari PS NJP Dist. Jalpaiguri and other 6/7 persons and arranged for its investigation.
