I SAGAR DEVI, wife of Uday Paswan, resident of New Pokaijote, Mallaguri, P.S- Pradhan Nagar, Dist - Darjeeling, would like to inform you that my daughter namely Radhika Kumari Paswan aged about 13 years on 27/08/2024 at about 10.00 a:m when she went to school and after the school closing hours my said daughter did not return home as such I became worried and started to search her and went to her school namely Dr. Rajendra Prasad Girls High School, Dangipara, Ward No 06, Siliguri and from the school I come to know that she did not come to the school on that day and then I and my family members started to search her at all possible places where she could be found, like in the house of my friend and relatives in Siliguri and even in the house of friend and relative in Bihar but could not trace her since last two days.

That today i.e on 29/08/2024, I came to know from our thorough search and enquiry that on 27/08/2024, at around 10:00 a:m my minor daughter was standing near Mallaguri for catching auto/toto for going to school and at that time one Abhishek Yadav (whose mobile number is 8409537075), Son of Bhagwan Lal Yadav, of Harauli P.S & P.O. Kusesharsthan, Dist- Darbhanga, had forcefully taken away my daughter with him as my daughter was crying for help when he was taking away my daughter but none saved her. Abhishek Yadav had taken away my minor daughter for illegal purpose and may do anything with her. I am in very much fear that any untoward incident may take place with my minor daughter

So I therefore request to you kindly take necessary legal action against the aforesaid culprit for the commission of the aforesaid offences by him..
