Sir,

In producing herewith four (05) accused persons namely (i) Sambhu Biswas @ Chhattu (29 yrs) S/O Golak Biswas of Dakshin Palash, PO- Champasari, Dist.- Darjeeling (ii) Mukesh Biswakarma (27) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Arun Biswakarma (20) S/O Lt. Raju Biswakarma of Harin Budhrbiri, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling (iv) Amit Singh (20 yrs) S/O Lt Saltu Singh of Durga Nagar, Gurung Busty, PS- Pradhan Nagar, Dist. Darjeeling (v) Chhotu Prasad Das (31 yrs) S/O Late Salik Prasad Das of Rajib Nagar Colony, Darjeeling More, PS- Pradhan Nagar, Dist.- Darjeeling under arrest and the following articles under seizure viz :- (i) one iron made hammer measuring 10 inches in length including its wooden butt (ii) one iron made sharp cutting weapon locally called "Hasua" measuring 17 inches in length including wooden Butt, (iii) one iron made weapon locally called as Dagger measuring 15 inches in length including its wooden butt (iv) one oron made weapon locally called as "Dau" measuring approx 17 inches in length including its wooden butt (v) iorn iron made rod "Sabol" measuring approx 17 inches in length and (vi) one multy colour nylon bag. I, ASI Prabal Sarkar of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted five (05) arrested accused persons and their 06/07 unknown associates who involve in this crime to the effect that on 30.08.2024 at 22.35 hrs received a specific source information that about 10/11 miscreants equipped deadly weapons assembled at near SNT, Siliguri Junction under PS- Pradhan Nagar, Dist.- Darjeeling and were taking preparation for committing dacoity at Pradhan Nagar and its surrounding areas.

Accordingly, I informed the matter to you and diarized the fact in General diary vide Pradhan Nagar PS GDE No. 1883 dated 30.08.2024. As per your kind order and direction, I along with with With ASI Biplab Kr Das C/1415 Chandan Basak, C/1413 Sujit Sarkar, C/1119 Tamnoy Roy and C/1416 Dilip Barman all of Pradhan Nagar PS left for Siliguri Junction under Pradhan Nagar PS, Dist.- Darjeeling by Govt. vehicle with investigation kits to verify the veracity of the information without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of a sensitive information and not to afford them opportunity for concealment of evidence or facility for his escape. I informed one videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist.- Darjeeling and requested him to come to Siliguri Junction for the purpose of videography if required. On the way, I briefed all the Police personnel sharing the information in hand and also informed RT van officer ASI Sanjoy Sarkar of Pradhan Nagar PS and requested him to come to Siliguri Junction to accompany with us. We arrived at Siliguri Junction near SNT and contact with my source while he stated that the miscreants assembled near SNT. Then, I contacted with independent witnesses namely (i) Sahil Khan (25), S/O Late Ali Aktar Ali Khan of Baghajatin Colony near Radha Krishna Mandir, PS. Pradhan Ngar, Dist. Darjeeling and (ii) Mahadeb Sarkar (29), S/O Manik Sarkar of Baghajatin Colony near Radha Krishna Mandir, PS. Pradhan Ngar, Dist. Darjeeling and I informed them regarding the information and requested them to remain present and act as witness if any search and seizure would be made, upon which they agreed. In the mean time night RT van Officer ASI Sanjoy Sarkar along with his force and the above named vediographer arrived there and accompany with us. I briefed him and his team properly.

Thereafter, being pointed by the source from a considerable distance we noticed that some persons assembled near SNT, Siliguri Junction under PS- Pradhan Nagar, Dist.- Darjeeling and they were whispering in a very low voice. We cordoned the place with due care and caution. On seeing police personnel approaching towards them they tried to flee away from the spot but on hot chase we managed to apprehended above noted five (05) accused persons while 06/07 others managed to fled away from the spot. Thereafter, we disclosed our identities as Police personnel (as we were in civil dress for our convenience). On interrogation, they disclosed their identities as noted above. On search recovered one multi colour nylan bag containing the above noted weapon of offence from Sl No. (1) to (5) recovered from their joint possession.

On further interrogation, they furnished incoherent statements and failed to give any satisfactory reply for their presence with deadly weapons in such deaf hour of night. Finally they disclosed that they along with 06/07 of their associates assembled there and were making preparation for committing dacoity at Pradhan Nagar and its surrounding areas. Accordingly, I seized the above mentioned weapons of offence from their joint possessions under proper seizure list in between 23.10 hrs to 23.40 hrs duly signed by the witnesses and acknowledged by the accused persons and subsequently arrested them under proper memo of arrest and observing all the formalities of arrest. They are informed over the ground of arrest. The whole process of search and seizure were made under the coverage of video graph by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS- Siliguri, Dist.- Darjeeling as per norms of BNSS and brought all the five (05) arrested accused persons along with seized articles to Pradhan Nagar Police Station for further investigation.

From the above noted facts and seizure of incriminating articles there is strong reason to believe that all the above noted five (05) accused persons along with others who fled away gathered there equipped with deadly weapons at such dead hour of night and taking preparation to commit dacoity in a nearby affluent area at Pradhan Nagar and its surrounding areas.

Under the above circumstances, I pray before you that a specific case under proper section of Law against may kindly be started against the above noted five (05) arrested accused persons namely (i) Sambhu Biswas @ Chhattu (29 yrs) S/O Golak Biswas of Dakshin Palash, Po-Champasari, Dist.- Darjeeling (ii) Mukesh Biswakarma (27) S/O Rajen Biswakarma of Nandok, PS. Ranipool, Dist. Gangtok, East Sikkim (iii) Arun Biswakarma (20) S/O Lt. Raju Biswakarma of Harin Budhrbiri, PS. Jhapa, Nepal, A/P Darjeeling More, PS. Matigara, Dist. Darjeeling (iv) Amit Singh (20 yrs) S/O Lt Saltu Singh of Durga Nagar, Gurung Busty, PS- Pradhan Nagar, Dist. Darjeeling (v) Chhotu Prasad Das (31 yrs) S/O Late Salik Prasad Das of Rajib Nagar Colony, Darjeeling More, PS- Pradhan Nagar, Dist.-Darjeeling and others 06/07 unknown miscreants and arrange for its investigation.
