I SI Nirmal Kr. Das, Officer in Charge of New Jalpaiguri PS , Siliguri Police Commissionerate, Dist. Jalpaiguri do hereby lodged this complaint as suo-motu against 1. Bapi Poul , Member of BJP District Committee 2. Sujay Biswas , President BJP 6 no. Mandal Committee of Lake Town, W.No 33 PS NJP Dist. Jalpaiguri 3. Rajib Saha, Vice President BJP Fulbari Mandal Committee of Dhakai Busty, Purba Dhantala PS NJP Dist. Jalpaiguri 4. Pritam Singha 5. Matiar Rahaman @ Puchu S/o Ajijul Hoque of Purba Dhantala PS NJP Dist. Jalpaiguri of Fulbari 6. Shyamal Biswasharma of Surya Sen Colony PS NJP Dist. Jalpaiguri 7. Mamani Das , BJP Mohila Morcha Fulbari GP-II, Paschim Dhantala 8. Bidhan Mandal of Purba Dhantala PS NJP Dist. Jalpaiguri 9. Shankar Sengupt, Vice President NJP 6 No. Mandal Committee and others, all are BJP supporters, to the effect that on 01/09/24 from 11.45 hrs, BJP supporters of NJP PS and adjacent PS area under the leadership of Ms Shikha Chatterjee, MLA, Dabgram Fulbari had assembled unlawfully and staged a Thana Gherao programme at NJP PS.

To prevent any hooliganism and vandalism at NJP PS by BJP supporters, we erected a barricade in front of main entrance of NJP police station using traffic road barrier, hired bamboos and ropes to restrain them.

At about 11-45 hrs Ms Shikha Chatterjee, MLA, Dabgram Fulbari along with about 100 supporters, both male & female included, of BJP carrying BJP flags shouting derogative, provocative and abusive words towards Police in general reached before that temporary barricade and all on a sudden attacked that barricade and broke down that barricade using manpower. As a result, 03 nos of traffic guardrail and 4/5 hired bamboos used to erect that barricade damaged and destroyed by them. They also restrained the police personnel for discharging Govt duty. However, timely interference of police they could not continued that vandalism and rest of the barricade could be saved.

Amongst those who had taken active part in destroying and damaging the barricade are identified as 1. Bapi Poul , Member of BJP District Committee 2. Sujay Biswas , President BJP 6 no. Mandal Committee of Lake Town, W.No 33 PS NJP Dist. Jalpaiguri 3. Rajib Saha, Vice President BJP Fulbari Mandal Committee of Dhakai Busty, Purba Dhantala PS NJP Dist. Jalpaiguri 4. Pritam Singha 5. Matiar Rahaman @ Puchu S/o Ajijul Hoque of Purba Dhantala PS NJP Dist. Jalpaiguri of Fulbari 6. Shyamal Biswasharma of Surya Sen Colony PS NJP Dist. Jalpaiguri 7. Mamani Das , BJP Mohila Morcha Fulbari GP-II, Paschim Dhantala 8. Bidhan Mandal of Purba Dhantala PS NJP Dist. Jalpaiguri 9. Shankar Sengupt, Vice President NJP 6 No. Mandal Committee and others all of BJP supporters.
